**RESOLUTION DESIGNATING AND COMMISSIONING SCHOOL SAFETY OFFICER AND ESTABLISHING THE
SCHOOL BOARD OF CLAY COUNTY, FLORIDA POLICE DEPARTMENT**

A RESOLUTION OF THE SCHOOL BOARD OF CLAY COUNTY, FLORIDA designating and commissioning a school safety officer pursuant to 1006.12, Florida State Statute, and authorizing and directing the Superintendent of Schools on behalf of the School Board, as employing agency, to take such actions as are necessary or appropriate to comply with the provisions of Chapter 943, Florida State Statute, and to effectuate the intent and purposes of this Resolution, and establishing the School Board of Clay County, Florida Police Department.

WHEREAS, the School Board of Clay, Florida is authorized pursuant to 1006.12, Florida State Statute, to commission one or more school safety officers for protection and safety of school personnel, property, and students with the school district; and

WHEREAS, the statute authorizes the Superintendent to recommend and the School Board may appoint one of more school safety officers; and

WHEREAS, it is intended by the School Board, as employing agency of said school safety officers for purposes of Chapter 943, Florida State Statute, and that an Originating Agency Identifier be obtained from the Florida Department of Law Enforcement to enable the school safety officer to have access to such criminal records and other information as may be available by virtue of the issuance of the Originating Agency Identifier; and

WHEREAS, the School Board intends to take all actions necessary to establish the "School Board of Clay County, Florida Police Department."

NOW, THEREFORE, BE IT RESOLVED by the School Board Of Clay County, Florida:

1. The School Board of Clay County, Florida Police Department is hereby established.
2. The Superintendent of Schools be, and hereby is, authorized and directed to take such actions as are necessary or appropriate to comply with the provisions of Chapter 943, Florida State Statute, and to effectuate the intent and purposes of this Resolution.
3. The Superintendent shall on behalf of the School Board, as the employing agency, apply for and obtain an Originating Agency Identifier from the Florida Department of Law Enforcement.
4. The Superintendent is authorized and directed to take such other and further action as deemed necessary or appropriate to effectuate the intent and purpose of the Resolution.
5. This Resolution shall take effect immediately upon adoption.

NOW, THEREFORE, BE IT RESOLVED THAT THIS RESOLUTION has been duly adopted by majority vote of the School Board of Clay County, Florida at a Special meeting held this 26th day of February, 2019.
