Healthy, Hunger-Free Kids Act Professional Standards in Schools



For the 2015-2016 School Year we implemented the Professional Standards in School which requires specific number of documented training hours per school year for Food and Nutrition Services employees.

2015-2016 Required Hours

- Director- at least 8 hours
- Cafeteria Managers-at least 6 hours
- All Other Staff- at least 4 hours

2016-2017 Required Hours

- Director- at least 12 hours
- Cafeteria Managers-at least 10 hours
- All Other Staff- at least 6 hours



Community Eligibility Provision (CEP)

This year we successfully implemented CEP in 6 schools. All students attending CEP schools received a breakfast and lunch free of charge with no application process. Our total breakfast participation increased 18% and our lunch participation increased 5%.
