

**Contract Modification Between
Pace Center for Girls, Inc., and The School Board of Clay County, Florida**

THIS FIRST MODIFICATION is made and entered into this **January 24, 2019**, by and between PACE Center for Girls, Inc., a non-profit corporation, located at One West Adams Street, Suite 301, Jacksonville, Florida 32202, hereinafter referred to as "PACE," and The School Board of Clay County, Florida, 900 Walnut St., Green Cove Springs, FL 32043, hereinafter referred to as "SCHOOL BOARD."

WHEREAS, PACE and SCHOOL BOARD entered into an agreement for the term January 1, 2015, to December 31, 2016, (the "Original Agreement"), and the agreement automatically renews for successive periods of one (1) year; and

WHEREAS, PACE and SCHOOL BOARD have agreed to modify the Original Agreement; and

WHEREAS, PACE and CONTRACTOR have reached agreement and wish to herein set forth the actions outlined below:

Section II., 1. is replaced with the following language:

SCHOOL BOARD will provide daily transportation, including arrival and departure, to students of PACE Clay, 1241 Blanding Blvd., Suite 5, Orange Park, FL 32065. Processes and procedures include:

- a. Four (4) SCHOOL BOARD buses operated by SCHOOL BOARD drivers will pick up PACE Clay riders at designated bus stops defined by the SCHOOL BOARD's Transportation Department.
- b. PACE Clay will submit change reports for any changes at least three (3) days in advance of expected adjustments to route or ridership.
- c. SCHOOL BOARD bus rules and student code will be enforced for all PACE Clay riders. Referrals will be used for documentation between the SCHOOL BOARD's Transportation Department and PACE Clay.
- d. PACE Clay will continue to submit FTE transportation reports quarterly FTE reporting period for funding from the Florida Department of Education. The SCHOOL BOARD's Transportation Department will provide PACE Clay with riding reports for which to compile the FTE reports. The SCHOOL BOARD will then invoice PACE Clay on a monthly basis for the total amount due. Refer to Exhibit A
- e. PACE Clay will provide staff supervision of students during arrival and departure at the PACE Clay Center.
- f. Transportation for students with special needs within two (2) miles of the PACE Clay Center will require an Individual Education Plan (IEP) documenting the need for transportation.
- g. SCHOOL BOARD will advise PACE Clay in advance of driver changes to allow for PACE approval of driver eligibility based on requirements from the Florida Department of Juvenile Justice (DJJ) for motor vehicle records (MVRs) and background screening. SCHOOL BOARD drivers must submit to and clear DJJ Level II background screenings, complete any required online trainings assigned by PACE, and agree to review of MVRs prior to driver's start date transporting Pace Clay students.

- h. PACE Clay will provide an annual calendar outlining service dates and times for by January 31 of each year.

All other terms and conditions of the Original Agreement remain in full force and effect.

IN WITNESS WHEREOF, the parties hereto have executed this First Modification on the date first written above.

When signed by representatives of both parties, this modification constitutes a binding agreement between the SCHOOL BOARD and PACE. 


