**AMENDMENT 1 TO THE INDEPENDENT CONTRACTOR SERVICES
AGREEMENT BETWEEN THE SCHOOL BOARD OF CLAY COUNTY, FLORIDA AND
LEARNING 2020, INC. D/B/A/ PENDA LEARNING**

This Amendment 1 to the independent Contractor Services Agreement between the School Board of Clay County, Florida (“SBCC”) and Learning 2020, Inc. DBA. Penda Learning (“Penda” or “Contractor”) collectively referred to as the “Parties”, which original Agreement was entered into on August 5, 2021 by the Chairman of SBCC, shall become effective on the date last executed by either of the parties and shall serve to modify the original Agreement only as set forth herein.

WHEREAS, Penda agreed to provide a science subscription service to SBCC for grade levels four (4) through ten (10), serving a total student population of 20,560 students and on-site professional development for 8 teachers, and

WHEREAS, the Agreement was for a period of three years at a total cost, after discounts, of \$618,425.82 cents, and

WHEREAS, the purpose of the subscription service was to provide cloud based science content including science activities, simulations and grade level assessment activities all of which are designed to remediate and also to accelerate student progress in science, and

WHEREAS, after utilizing the product for a period of time, SBCC has determined that it could best serve its students by providing the program to all third grade students in the district, and

WHEREAS, Penda has proposed making their subscription service available to all third grade students (3022) in the SBCC district for the remaining term of the original Agreement for an additional total cost, after discounts, of \$60,500.44, the details of which proposal are set forth in Exhibit A which is attached hereto,

NOW THEREFORE, the Parties agree to modify the terms of the original Agreement as follows:

1. Penda, in addition to providing their subscription service as set forth in the original Agreement dated August 5, 2021, agrees to provide their cloud based

science content subscription service to all third grade students served by the SBCC throughout the Clay County School District.

2. The provision of the additional services set forth in the previous paragraph shall commence immediately upon full execution of this Agreement by all parties and shall terminate on July 31, 2024, on the same date as the termination of the original Agreement to which this serves as an amendment.

3. The additional cost of adding the additional services set forth in the paragraph numbered 1 and referred to in the previous paragraph shall be \$60,500.44, which amount when added to the full discounted amount of the original Agreement executed on August 5, 2021, (\$618,425.82) shall make the total price of the original Agreement, coupled with the cost of the additional services provided for by this Amendment \$678,926.26.

4. The only effect of this Amendment is to modify the terms of the original Agreement signed by the SBCC Chairman on August 5, 2021, as set forth herein.

5. All other terms and conditions of the original Agreement, together with all attachments to the original Agreement shall remain unmodified and in full force and effect.

IN WITNESS WHEREOF, the parties, by the execution of this Amendment by their authorized representatives below, bind themselves to all terms of this Amendment to the original Agreement and to the remaining unmodified terms of the original Agreement.
