As you are aware we have encountered multiple weather delays since beginning the construction of the new elementary school. Each of these delays are beyond typical weather patterns that we experience with projects of this size and duration. Two major weather events are the primary cause of our delays. Hurricane Irma was our first major delay and the recent non-typical weather pattern in late May provided heavy rains each day for over two (2) weeks.

In addition, multiple owner requested change orders near project completion have affected our schedule. These changes received board approval in May 2018 and have also delayed our completion date. Please note that the covered play building is the main consideration here.

It is for these reasons that we respectfully request that twenty-eight (28) days be added to the construction schedule. This proposed change provides for a new substantial completion date of July 2, 2018.

Please note that we have maintained the owner furniture delivery and installation dates. At this time over 60% of this furniture (phase 1 & 2) is inside the buildings and the staff desk phone installation is scheduled for next week. We anticipate the issuance of temporary certificates occupation (TCO) for phase 1 and 2 next week. Phase 3 TCO is scheduled for June 18th and our last shipment (phase 3) of furniture is scheduled for June 25th.

As you can see the remaining work is being completed while major steps towards occupancy are achieved. We will continue to work hard every day to ensure that we are ready to open well in advance of the new school year.
