LEGAL DESCRIPTION

A PORTION OF THE SOUTHWEST $\frac{1}{4}$ OF SECTION 30, TOWNSHIP 5 SOUTH, RANGE 25 EAST, AND A PORTION OF THE SOUTHEAST $\frac{1}{4}$ OF SECTION 25, TOWNSHIP 4 SOUTH, RANGE 24 EAST, CLAY COUNTY, FLORIDA, AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCE AT THE NORTHWEST CORNER OF SAID SECTION 30, SAID CORNER BEING ON THE NORTHERLY BOUNDARY LINE OF PINE RIDGE PLANTATION, ACCORDING TO PLAT THEREOF, RECORDED IN PLAT BOOK 52, PAGES 20 THROUGH 45 OF THE PUBLIC RECORDS OF SAID COUNTY; THENCE ALONG THE NORTHERLY, NORTHEASTERLY, EASTERLY AND SOUTHERLY BOUNDARY LINE OF SAID PINE RIDGE PLANTATION, RUN THE FOLLOWING EIGHT (8) COURSES: (1) NORTH $89^{\circ} 34' 13''$ EAST, 327.77 FEET; (2) SOUTH $40^{\circ} 48' 13''$ EAST, 1032.23 FEET; (3) NORTH $53^{\circ} 32' 15''$ EAST, 248.48 FEET; (4) SOUTH $56^{\circ} 45' 29''$ EAST, 1877.15 FEET; (5) SOUTH $00^{\circ} 00' 20''$ EAST, 1125.77 FEET; (6) SOUTH $83^{\circ} 19' 51''$ WEST, 1317.62 FEET; (7) SOUTH $00^{\circ} 15' 15''$ WEST, 359.35 FEET; (8) SOUTH $89^{\circ} 51' 24''$ WEST, 145.65 FEET TO THE WESTERLY RIGHT-OF-WAY LINE OF TYNES BOULEVARD (A 115 FEET RIGHT-OF-WAY AS NOW ESTABLISHED, ACCORDING TO PLAT BOOK 51, PAGES 25 THROUGH 28 OF THE PUBLIC RECORDS OF SAID COUNTY); THENCE CONTINUE SOUTH $89^{\circ} 51' 24''$ WEST, 1005.63 FEET; THENCE SOUTH $39^{\circ} 47' 23''$ WEST, 205.74 FEET TO THE **POINT OF BEGINNING**; THENCE CONTINUE SOUTH $39^{\circ} 47' 23''$ WEST, 46.96 FEET; THENCE SOUTH $89^{\circ} 51' 24''$ WEST, 190.30 FEET; THENCE SOUTH $00^{\circ} 26' 53''$ WEST, 113.00 FEET; THENCE NORTH $89^{\circ} 51' 24''$ EAST, 343.00 FEET; NORTH $00^{\circ} 26' 53''$ EAST, 149.00 FEET; THENCE SOUTH $89^{\circ} 51' 24''$ WEST, 122.93 FEET TO THE **POINT OF BEGINNING**.



CCUA WATER TREATMENT PLANT SITE






