This year I have looped up with my 3rd graders to 4th grade and only using LAFS I have seen a decrease in my student's excitement for reading, unengaged students involved with their Independent Daily Reading, and have felt like a robot-teacher going page by page in a workbook very disheartening. Obviously I have more room to grow in my personal professional development with LAFS, and am hopeful that there will be more trainings if our county does go to this adoption. These activities get my students excited about reading, exposes them to difficult text, and lays the foundation for finding the evidence and proving their answer. The LAFS books do a great job of exposing the students to multiple choice questions that I would be unable to create myself. For my students, I feel that I get the best use out of them by introducing them in December or January. By this time, they have had exposure to many of the 3rd grade standards, now we are ready to master these skills. I do not simply take them up and grade them. They are graded while students are working so that they have the opportunity to see their mistakes and we talk about why one was a better choice than what they chose. Most lessons are completed in whole group, however, I will do some lessons in small group so that I know every student is really paying attention to the instruction.
