

Memorandum of Understanding  
Between  
Pragmatic Works  
And  
St. Johns River State College  
And  
Clay County School District Career and Technical Education Department

**INTENT AND PURPOSES**

Since there is a growing need for skilled workers in the Information Technology Industry who continue toward postsecondary education and industry certification, the parties desire to establish a relationship to improve the dual enrollment and postsecondary transition opportunities of Clay County students. To this end, Pragmatic Works, St. Johns River State College (SJR State) and Clay County School District (CCSD) agree to establish this agreement for dual enrollment opportunities in computer science.

**REQUIREMENTS**

Pragmatic Works agrees to pay for the instructional cost associated with an SJR State faculty to provide dual enrollment instruction at a site designated by the Clay County School District. Courses taught on the high school campus by an SJR State adjunct or full time instructor as an overload with a Masters Degree: \$580.00 per credit hour. Courses taught on the high school campus by an SJR State adjunct or full-time instructor with a Doctorate Degree: \$664.00 per credit hour.

In addition Pragmatic works agrees to pay for the cost of textbooks for each student enrolled in the course to the Clay County School District.

Clay County School District agrees to provide computer lab facilities for instruction.

To be eligible for this program students must meet all eligibility requirements for the SJR State Dual Enrollment program as outlined in the Interinstitutional Agreement between the Clay County School District and SJR State.


**TERMS AND CONDITIONS**

This agreement is subject to all applicable Florida laws, rules and regulations and may be changed by the parties as a result of actions by the Florida Legislature, the Florida Department of Education, the Clay County School Board or the St. Johns River State College Board of Trustees.

This Agreement may be terminated by either party upon 30 days prior written notice to the other parties. This agreement shall automatically terminate on June 1, 2017 unless extended in accordance with the terms hereof. This agreement may be extended for additional one (1) year terms under the same terms and conditions contained herein upon prior written agreement of all parties at least thirty (30) calendar days prior to the expiration of the then current term of this agreement.


