Discussion followed about how the Board should proceed with future legal services and hiring a new attorney. An item will be added to the November 1st agenda to continue discussion: *Discuss and give direction on process for employing legal services*.
- There was discussion about the process for student discipline and for bringing expulsion cases to the Board. Mr. Davis will include an update in his followup to the Board.
- A reminder was given about the Board workshop scheduled for October 30, 2018, at 8:30 a.m. to continue review of Board policies.
- There was brief discussion about the effects of Hurricane Michael on school districts in the panhandle. As a result, Clay County may be picking up additional students in the Clay Virtual Academy.
- Positive comments were made about the successful second *FirstBooks* event. Approximately 1821 attended. Leftover books will be sent to Jackson County as part of the disaster relief drive.

• Mrs. Bolla requested consideration of a workshop to discuss a proactive plan for the growth expected in Clay County over the next few years. The workshop will be planned for January after the holidays. Mrs. Studdard plans to put an item on the January agenda to review the Superintendent's salary.
