The Executive Director of the Education Foundation is a Director III position that reports to the Superintendent of Schools. The Executive Director is responsible for leadership and management of the Clay County District Schools' Foundation. The primary role of the director is to develop a comprehensive fundraising program strategy, including annual fundraising events, planned giving, endowments, and an increase in unrestricted dollar donations; identify and cultivate key donor prospects on behalf of the Foundation.

Job Description:

The Executive Director of the Education Foundation is responsible for leadership and management of the Clay County District Schools' Foundation, a not-for-profit philanthropic organization comprised of community leaders in partnership with our school system whose mission has been investing in the future of Clay County's students. The Executive Director communicates and drives the Clay County District Schools' vision and provides leadership to the Education Foundation and district staff in formulating goals aligned to district benchmarks. He/she leads with action and initiative, and defines, articulates, and responds to the ever-changing philanthropic environment. The Executive Director must provide leadership in developing financial resources and maintaining relationships with Clay County District Schools' constituents.

Responsibilities and duties of this position include:

1. Develops a comprehensive fundraising program strategy, including annual fundraising events, planned giving, endowments, and an increase in unrestricted dollar donations; identify and cultivate key donor prospects on behalf of the Foundation.
2. Works in collaboration with the Board of Directors of the Clay Education Foundation, to develop short and long range fundraising goals and program development plans for the Clay Education Foundation; establish monitoring mechanism to ensure program effectiveness and the achievement of Foundation goals.
3. Acts as the Clay County District Schools' executive leadership representative for the Clay Education Foundation, Inc., to identify and develop potential funding sources by building and maintaining strategic relationships.
4. Establish linkages and alignments with internal and external entities, such as community boards, that can increase the Foundation's effectiveness in achieving its goals by serving as liaison between the Clay Education Foundation, school district, government, community, and key business/industry leaders in Foundation activities, Ad Hoc Committees, and collaborative advisors.
5. Develop and implement effective marketing, communications, and public relations plans to increase public awareness of the mission of the Clay Education Foundation, the value of the programs they support to increase the potential to develop significant donor support.
6. Ensure the availability of information to promote the Clay Education Foundation by preparing necessary reports, articles, publications, new releases, and other material as needed by the Board of Trustees, School Board, committees, funders and the community in coordination with the Communications Department.
7. Determine availability of alternative funding sources by applying for federal, state, and local grants.
8. Remain current on changes affecting the professional fund-raising community by visiting other Foundations and attending pertinent workshops.
9. Serve as official spokesperson for the Foundation and participate in activities that increase the visibility of the Foundation – at Foundation events, in the school community and in the community at large.
10. Manage and monitor the business and financial operations of the Foundation, ensuring fiscal accountability and compliance with board policies and legal requirements.
11. Plan, organize and implement marketing strategies to increase school business partnerships, mentors, and revenue for the Clay Education Foundation. Develop and maintain a donor history and database on all business partnerships.
12. Coordinate programs such as the Teacher of the Year, Support-Related Employee of the Year, Business Partner of the Year, Foundation Mini-grants, scholarships, etc., to enhance the image of the school district through cooperative ventures with the business community.
13. Assist in documentation and accurate record keeping of all revenue generated by the Clay Education Foundation.
14. Performs other duties as requested by the Superintendent of Clay County Schools.

1. Bachelor's Degree in Business, Communications or related field; or related experience commensurate to the responsibilities of the position.
2. Knowledge of Florida Statutes and policies relative to a nonprofit organization.

C-3.3.10 Capital Program Accountant

Currently, the Capital Program budget is in excess of \$40 million dollars annually and requires significant and skilled accounting responsibilities in the management of all capital funding sources of revenue for the Operations Division. Unlike other divisions that have multiple administrative positions overseeing financial accounting functions, Operations has only had one lower level support position overseeing the accounting functions for multiple capital revenue streams within facilities and maintenance. The current pay classification of B24 is not in alignment with the scope of work and financial accounting responsibilities; therefore, I am appropriately adjusting this support position to the B32 classification at a minimum until such time the district is in a financial position to appropriately staff Operations with additional administrators. A new job description for Capital Program Accountant has been created with aligned job responsibilities and experience qualifications as appropriate.

Job Description:

The Capital Program Accountant is responsible to the Assistant Superintendent for Operations and provides financial accountability support to all Departments within the Operations Division.

Responsibilities and Duties of this Position:

1. Work directly with the Assistant Superintendent to manage all Operations related general and capital funding revenue sources.
2. Enter, track and process all purchase orders and invoices for direct purchasing of materials for Capital Outlay projects. Work closely with Contractors and suppliers to verify materials are received. Prepare Change Order for Board approval that reduces the Contractors contract by the amount of purchased materials plus tax.
3. Enter, track and process all purchase orders and invoices from the General Operating funds (100) for the Facility Planning & Construction, Code Enforcement and Operations Departments.
4. Process all Architect, Engineer and Contractor pay applications for Capital Outlay funded projects.
5. Track all Capital Outlay funding. Ensure that funds are being spent correctly by verifying advertisement and/or Florida Statute requirements. Work closely with Business Affairs team: Director of Finance, Coordinator of Budgeting, Supervisor of Purchasing and Material Management, and Coordinator of Accounts Payable.
6. Assist in preparing the Educational Facilities Plan by reconciling all available revenue and providing information to the Asst. Superintendent. Establish/create project fund lines for new fiscal year and work in conjunction with Business Affairs Chief Financial Officer and Director of Finance to prepare required public advertisements for Board approval.
7. Submit all budget amendments for the Facility Planning & Construction, Code Enforcement and Operations Departments.
8. Track all PECO New Construction Funding from the State. Prepare encumbrance authorization request to Department of Education. Maintain the original file. Assist Maintenance with PECO Special Maintenance funds.
9. Assist in preparing the Project Priority List (P.P.L.). This is required in order to expend CO&DS (360) funds on any projects. This list requires Board approval. Maintain the original file.
10. Assist in preparing the Cost of Construction required annually by the Department of Education. This report breaks down the cost of each project to ensure that we are building within the State approved cost per square foot. Maintain the original file.
11. Track hospitality money. Prepare request for use of funds and maintain spreadsheet of expenditures. Maintain the original file.
12. Track Division of Operations credit card expenditures. Provide documentation to Business Affairs for payment as appropriate.
13. Due to Code Enforcement being understaffed, this position assists with the secretarial responsibilities of completing SREF inspections as well as other secretarial needs of the department.

14. Provide construction project support to the Maintenance Department and Director of Support Services when projects are funded with Capital Outlay.
15. Provide daily support to Assistant Superintendent for Operations and performs all other duties as assigned.

Required Qualifications:

1. Must be a high school graduate or have passed the G.E.D. equivalency examination.
2. Must have experience producing financial summaries and reports utilizing Generally Accepted Accounting Principles (G.A.A.P).
3. Minimum of 10 years' experience with Capital Funding to include direct experience with managing General Fund, Local Capital Improvement Funds (L.C.I.F.), Impact Fees, Gas Tax, Public Education Capital Outlay (P.E.C.O), Capital Outlay and Debt Service (CO&DS), and other revenue sources as related.
4. Must have experience with Florida Statutes and Florida School Law related to Facilities, Planning & Construction
5. Must be technologically proficient with demonstrated ability to navigate efficiently within Enterprise Resource Programs (ERP) and software.
6. Possess effective interpersonal skills with demonstrated ability to coordinate and collaborate with Directors within the Operations Division to include direct support to Facilities, Planning, & Construction; Maintenance, Code Enforcement, Support Services, Transportation, and Food & Nutrition Services.
7. Must be self-directed and possess the ability to multi-task in a high-paced, deadline-driven environment.
