

## TEMPORARY CONSTRUCTION EASEMENT

On this 17th day of April, A.D. 2014, **THE SCHOOL BOARD OF CLAY COUNTY, FLORIDA**, a corporate body, whose business address is 925 West Center Street, Green Cove Springs, Florida 32043, owner of Clay County Parcel Number 07-04-26-013065-000-00, hereinafter called **GRANTOR**, does hereby grant to **CLAY COUNTY UTILITY AUTHORITY**, an independent special district existing and created under Chapter 94-491, Laws of Florida, Special Acts of 1994, whose business address is 3176 Old Jennings Road, Middleburg, Florida 32068, hereinafter called **GRANTEE**, a Temporary Construction Easement.

This Temporary Construction Easement (Shown on Exhibit A) is for the purpose of allowing GRANTEE to make a wet tap connection to its existing 12" water main which lies parallel and adjacent to Kingsley Avenue, within an existing 15' easement located on GRANTOR's property. Since there is not adequate room to achieve this wet tap within the existing easement, GRANTEE requests a Temporary Construction Easement, being 10 feet in width and 60 feet in length, at the location shown on the attached utility as-built. This Temporary Construction Easement will abut and be adjacent to the existing 15' wide easement, for a total of 60 feet x 25 feet.

GRANTOR hereby allows GRANTEE or GRANTEE's contractors to perform this work within the specified easement area to make the wet tap and install a new 8" water main that will cross under Kingsley Avenue. GRANTEE does hereby agree to restore all areas damaged by GRANTEE's activities within the Temporary Construction Easement area on GRANTOR's property, including replacing any shrubbery, sod, curbing, sidewalks, pavement, or plants, if it is determined that the damage to these items is the result of GRANTEE or GRANTEE's contractor's work activities.

This Temporary Construction Easement shall expire upon completion or no later than June 30, 2014 of the new 8" water main extension across Kingsley Avenue to the Kingsley, LLC shopping center.
