

Clay County Milestone Payments

The Professional Services fees outlined in Section 3 of the contract is based on the client using best practices within BusinessPLUS. As part of the implementation, SunGard consultants will advise the client on best practices and configure the software in accordance to such practices. Any requested changes to the SunGard recommended configuration will be outside the scope of the Milestones. Our ability to provide services on a timely basis within the scope of the project is dependent upon client cooperation throughout the project, including but not limited to the client's completion of all assignments with due diligence and on time. The client is also responsible for having appropriate staff in all consulting and training sessions as outlined in the Project Schedule Summary and visit Agendas.

Any services outside the services outlined in the contract will be performed and billed on a time and material basis following both parties' execution of a Change Order Form. Any changes to the scope of services may impact the originally agreed upon timelines.

For the purposes below, Production Ready is defined as configured and capable of being used as the official book of record in the client's Production environment. The client may choose to not 'go live' on a particular module, however if the module is setup and ready to go live, this is considered Production Ready.

The exact Production Ready dates may change if agreed upon by the client and SunGard Project Manager in planning the project. Any changes to the phases and timelines below will require a Change Order Form.

Optional Implementation Support is not built into the Milestones below. Should the client agree they would like to use Implementation Support, the dates and timeframe will be agreed upon by the SunGard Project Manager and the Client Project Manager, and in turn the project schedule will be determined at that time with a Change Order.

Milestone Payment Schedule

Both parties agree that the milestone dates are tentative in nature and may be changed as a result of the project planning process and the Business Process Reviews, or as a result of the acceleration/deceleration of the implementation schedule. Upon achievement of each milestone below, the SunGard Project Manager will present a milestone sign-off document to be signed-off by the client's Project Manager, and the associated payment amount will be invoiced by SunGard, and will be due and payable by the client.

Exact priorities and dates for each of the Phase 3 modules will be determined between the SunGard Project Manager and Client Project Manager during the Planning stage of the process.
