**Date and time:** March 28, 2007

**Conditions:** CCSD will provide a training site with suitable space and AV support to include a PA or sound system, Power Point projection equipment including a computer, screen and projector, and TV / VCR. CCSD will register each participant with name, title, address, phone number, and email, and will provide this list to Keys. CCSD will invite others from outside their school district to attend at the regular per person, with registration handled by KEYS.

KEYS TO SAFER SCHOOLS.COM will provide: (Option 1) A Two-day Trainer Certification Training by a Subject Matter Expert on *Assessing The Potentially Dangerous Student*, or (Option 2) a One-day training *Assessors*.
