CONTRACT FOR SERVICES

District Responsibilities

Good communication among the various parties involved in a study of this nature is essential; therefore; the School Board of Clay County, Florida is requested to provide the following:

- 1. Designate an employee to coordinate the various activities that will take place in the School Board of Clay County, including developing a calendar of activities for the study.
- 2. The Superintendent is requested to designate his existing Executive Leadership Team or another committee to provide oversight and input to the study.
- 3. Assist EMCS, Inc. in selecting up to six (6) comparable Florida School Districts.
- 4. Provide EMCS, Inc. with a listing of official job titles and copies of current job descriptions for the classifications included in the study.
- 5. Provide EMCS, Inc. with copies of current salary schedules and administrative procedures for all employee classifications.
- 6. The oversight committee will be asked to provide feedback on the proposed salary schedule(s) options alignment and rates, and administrative procedures.
- 7. Provide a matrix of the current salaries of all instructional personnel by degree and step.

- 1. Conduct a market analysis of six (6) peer districts.
- 2. Develop a five (5) year cost analysis for the current and proposed salary schedule.

- 4. Provide a final report containing the description of the methodology used, graphs of both average and minimum-maximum salaries of the benchmark positions from the comparable district(s), recommended salary schedule(s), administrative procedures, and a disk(s) containing the salary schedule(s) and procedures.
- 5. Subject to the desire of the Superintendent EMCS, Inc. will provide two (2) bound copies and a camera-ready copy to the School Board of Clay County.
- 6. EMCS, Inc. will conduct a one (1) day workshop for the Board to present the study and a one (1) day workshop for management personnel to be designated by the Superintendent.
- 7. Conduct a relational analysis of other salary schedules that may be impacted by this study.

Costs

The total cost of the study will be \$9,500 and includes all services and materials described above. The above cost is based on up to five (5) consultant days on-site by the EMCS staff. Additional on-site days requested by the School Board of Clay County will be at a rate of \$750 per day per consultant, plus travel expenses at rates established by the School Board of Clay County.
