Explanation/Narrative

- A. Salary listed is for one (1) full time equivalent Social Worker, a specialist supplement for a Social Worker assisting in implementation of Clay County Homeless Grant in Full Service Schools, and other personnel as needed to support the project. The staff positions are ten (10) month employees plus summer employment.
- B. Fringes benefits are related to the Social Worker position, and other personnel.
- C. Staff travel. The travel is to be performed by the Social Worker when they do home, school, and agency visits. The authorized reimbursement rate is not to exceed \$0.44.5 per mile.
- D. Staff training and education. This is travel, per diem, and registration expenses related to the Social Worker, their supervisor, and other support personnel.
- E. Printing, Photocopy, Postage costs. This is the estimated cost.
- F. Supplies and Materials for staff and students. Includes office supplies and educational materials that are not obtainable from other sources.
- G. Rental/Equipment. Equipment used to support the Social Worker and other personnel providing services to support the project.
- H. Maintenance on Social Worker County vehicles
- I. Contracted Services for family counseling and assistance through First Coast Family Center.
