Project Design

Project Abstract

The Multiagency Network for Students with Emotional/Behavioral Disabilities (SEDNET) 4 is designed to provide a systems approach of integrating education and mental health services for students with emotional disturbances and their families. The goal is to improve academic gains and increase graduation rates. SEDNET serves as a mechanism for the School District of Clay, Duval, Baker, Nassau, and St. Johns Counties. The Project Manager and stakeholders work together to ensure that the project accomplish the work scope outlined in this grant application. Project goals, objectives and activities are directed by DOE and are supported and reviewed by local stakeholders including; Exceptional Student Education (ESE), Substance Abuse and Metal Health (SAMH), Community Based Care (CBC), Provider Board, Association for Persons with Disabilities (APD), Department of Juvenile Justice (DJJ), Department of Children and Families (DCF), and Medicaid. Additionally, they aid in the dissemination of information to all concerned parties regarding behavioral (mental health and substance abuse) best practices for students and their families who have or are at risk of developing emotional/behavioral disabilities. SEDNET, Professional Development Plan (PDP), and FDLRS routinely work together as a local team to bring support and technical assistance to schools in need. This year alternative training formats will be used to reduce face to face trainings.

Initiatives

Project initiatives will continue to strive to improve local services to Emotional/Behavioral Disabled (E/BD) students and their families. All project activities are based on the belief that the system of care should be student and family centered and community based. Project activities will strive to improve academics, behaviors, and transition from school to work.

In this application, funds are sought to engage in a variety of activities designed to meet the following DOE initiatives:

- Provision of a system to monitor and promote a comprehensive system of care that includes
 education, mental health treatment, and residential services for students with or at-risk of
 emotional/behavioral disabilities.
- An increase in the effectiveness of existing education, mental health treatment, and residential services for students with or at-risk of emotional/behavioral disabilities.
- Maintenance of the system for continuous multi-agency planning, implementation, and evaluation of education, mental health treatment, and residential services for students with emotional/behavioral disabilities.
- Sharing of information, materials, and resources for services for students with emotional/behavioral disabilities, including but not limit4ed to collaboration with Florida's Positive Behavior Support (PBS), Florida's Problem Solving/Response to Intervention State Pilot Program and projects that address secondary transition.

Expected Outcomes/Project Goals – The following outcomes/goals are identified for the project:

- Provide individual programs for students with emotional/behavioral disabilities that include necessary educational, residential, and mental health treatment services
- Enable identified students to learn appropriate behaviors, reduce dependency, and fully participate in all aspects of school and community living

- Identify necessary programs and services as close as possible to the student's home in the least restrictive manner consistent with the student's needs
- Integrate a wide range of services that are necessary to support all IDEA, Part B, eligible or atrisk students and their families
- Support and represent the needs of students in each school district in joint planning with fiscal agents of children's mental health funds
- Expand school-based mental health services and integrated education and treatment programs
- Assist multi-agency advisory boards in identifying issues critical to students of mutual concern and developing local response systems
- Increase parental involvement with local systems of care
- Improve coordination of services for children with emotional/behavioral disabilities and their families
- Help district staff acquire the knowledge and strategies necessary to implement the requirements of No Child Left Behind Act including, but not limited to, research based instructional practices, Highly Qualified Personnel, and Adequate Yearly Progress.

State Performance Plan

SEDNET will support the bureau by providing technical support on indicator of the state performance plan:

- o Indicator 1: Percent of youth with IEPs graduating from high school with a regular diploma compared to percent of all youth in FL graduating with a regular diploma.
- o Indicator 2: Percent of youth with IEPs dropping out of school
- o Indicator 4: Rates of suspension and expulsion
- o Indicator 13: Percent of youth aged 16 and above with an IEP that includes coordinated, measurable, annual IEP goals and transition services that will reasonably enable the student to meet the post-secondary goals.
- o Indicator 14: Percent of youth with IEPs who are no longer in high school who are transitioning into the community and world of work.
