On 5-14-07, at 1133 hours, I was contacted by Clay High School Assistant Principal Cary Dicks at the school reference a theft.

Mr. Dicks told me that sometime between 5-8-07 at 1340 hours and 5-10-07 at 0730 hours someone removed a Hitachi LCD multimedia projector from room #307(Lonnie Jones`s classroom). He also said that on 5-9-07 Lonnie Jones had a substite(Barbara Jordan) and that Mrs. Jordan did not remember seeing the projector in the classroom. Upon Mr. Jones return to the classroom at the start of school on 5-10-07 the projector had been taken. The projector estimated value is \$1,700.00. A written statement was obtained from Mr. Dicks.

I was unable to obtain written statements from Lonnie Jones or Barbara Jordan at this time.

No suspect or witness information.

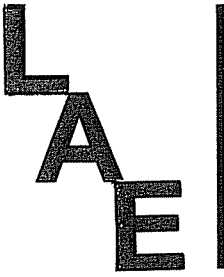
No forced entry to the classroom was observed.

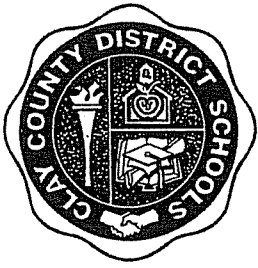
