February 2013 Amendment

This February 2013 Amendment (the "*Amendment*") is made and entered into by and between Lutheran Services Florida, Inc. ("*LSF*") and School District of Clay County SEDNET. ("*Provider*") to be effective as of July 1, 2012. Provider and LSF may be referred to herein individually as a "*party*" or collectively as the "*parties*".

WHEREAS, LSF wishes to amend the contract entered into between said parties on July 1, 2012. The purpose of this amendment is to increase funding and services and replace Standard Contract, Paragraph 3, "Payment for Services"; Attachment 1, Section C, Paragraph 1; Attachment I, Exhibit B-1, "Line Item Operating Budget" and Exhibit C-1, "Budget Narrative".

NOW THEREFORE, in consideration of the mutual covenants, representations, and the mutual promises contained hereinafter, and in exchange for good and valuable consideration, the sufficiency of which is hereby acknowledged, the parties, as independent contractors, agree as follows:

- 1. Capitalized terms herein shall be ascribed the meaning given by the Agreement. In the event of conflict between this Amendment and the Agreement, this Amendment shall control.
- 2. Standard Contract, Paragraph 3, 'Payment for Services' is amended to include new contract amount for the period FY 2012-2013 not to exceed <u>\$115,996.00</u> applicable to Covered Services rendered to eligible consumers, subject to availability of funds.
- 3. Amending Attachment 1, Section C, Paragraph 1 to read:
 - This is a cost reimbursement contract. LSF will reimburse the provider for allowable expenditures incurred pursuant to the terms of this contract for a total dollar amount not to exceed <u>\$115,996.00 FY12-13</u>, subject to the availability of funds. The allowed expenditures for reimbursement are listed on Exhibit C-1, "Budget Narrative".
- 4. Amending Exhibit B-1, "Line Item Operating Budget" to include new Exhibit B-1, "Line Item Operating Budget" is attached hereto and incorporated herein by reference. All prior Exhibits and Attachments with reference to same content are deleted.
- 5. Amending Exhibit C-1, "Budget Narrative" to include new Exhibit C-1, "Budget Narrative" is attached hereto and incorporated herein by reference. All prior Exhibits and Attachments with reference to same content are deleted.

Except as amended hereby, the terms and conditions of the Agreement remain the same.

The parties authorized representatives have executed this Amendment to be effective as of February 1, 2013.
