All other Divisions/Departments/Schools	7:30 a.m. to 5:30 p.m., including 40 minute lunch

HOLIDAYS: Independence Day (Observed) - Wednesday, July 4, 2012

EXCEPTIONS:

- 1. Certain individuals in departments generally observing a 4-day week may be designated to observe a 5-day week when this is in the best interest of the district.
- 2. The Superintendent may approve variations in daily reporting and dismissal times by up to 30 minutes (i.e., 7:00 a.m. to 5:00 p.m. or 7:30 a.m. to 5:30 p.m.)
