Local Discretionary Sales Surtax ~ School Capital Outlay Surtax -0.5%

a.The School Board in each county may levy, pursuant to resolution conditioned to take effect only upon approval by a majority vote of the electors of the county voting in a referendum, a discretionary sales surtax at a rate that may not exceed 0.5%.

- b. The resolution shall include a statement that provides a brief statement and general description of the school capital outlay projects to be funded by the surtax.
- c. The resolution shall set forth a plan for use of the surtax proceeds for fixed capital expenditures or fixed capital costs associated with construction, reconstruction, or improvement of school facilities which have a useful life expectancy of 5 or more years, and any land acquisition, land improvement, design, and engineering costs.

- d. There are currently 16 school districts that impose a 0.5% School Capital Outlay Surtax.
- e. The district currently participates in the County 1% Local Discretionary Sales Surtax and receives 10% of the 1% and has budgeted \$1,800,000 in 2006-07. The sales tax in the County is 7%.
- f. The O.5 School Capital Outlay Surtax over 20 years would generate app. \$271,300,000 in revenues. Bonding capacity would be app. \$103 million.
- g. Cost to a typical household: \$100 a year.
