- 13. TIGHTEN SCHOOL BOARD POLICY (4.06(B)) TO STATE THAT SCHOOL BOARD EMPLOYEES MAY ENROLL THEIR CHILDREN INTO A SCHOOL ATTENDANCE BOUNDARY OTHER THAN THE ONE THEY RESIDE, WHICH IS AT OR CLOSE TO WHERE THEY WORK, AS LONG AS THE SCHOOL IS NOT OVER CAPACITY. (TEACHER OR EMPLOYEE OR BOTH?)
