See contractor's Change Order #5: Supply and install wood backing at new aluminum stairs to prevent "toe-catch", apply anti-slip tread tape on face of wood. Prime and paint new wood backing (at stairs) to match existing concrete (Gray). Prime and paint fascia pieces on telescopic bleachers (Black). Supply and install new 4-ft steps in grandstands. Additional painting of low walls in Gym where bleachers were removed. Clean and treat all areas of mold and mildew on low roof walls. Repaint these areas with elastomeric coating. Prep Paint EIFS/Stucco wall surfaces on all four lower roof wall sections. Provide concrete splash blocks at base of exposed downbspouts (10).
