AMENDMENT NO. 2 TO ENA UNIFIED MASTER SERVICES AGREEMENT

This Amendment No. 2 to the ENA Unified Master Services Agreement (“Amendment”), is made as of April 1, 2025 (“Amendment Effective Date”) by and between Clay County School Board (“Customer”) with its principal place of business at 900 Walnut St., Green Cove Springs, FL 32043, and ENA Services, LLC, (“ENA”) with its principal place of business at 618 Grassmere Park #12, Nashville, TN 37211. Customer and ENA may be referred to herein individually as a “Party” and collectively as the “Parties.”

WHEREAS, Customer and ENA are parties to that certain ENA Unified Master Services Agreement effective as of 2/07/2019 (“Agreement”); and

WHEREAS, Education Networks of America, Inc. and its subsidiaries (including ENA Services, LLC) were purchased by Zaya Group Holdings, Inc. by Equity Purchase Agreement dated February 25, 2022. On January 1, 2025 the name of both companies shall change from ENA Services, LLC to Zayo Education, LLC and Education Networks of America, Inc. to Zayo Education Inc., and both may be referred to generally as "Zayo Education" in any documentation provided to Customer going forward. The entity name that is listed in any documentation will change on January 1, 2025. Any federal and state registration numbers will stay the same and billing will not be affected by the name change.



WHEREAS, the Parties wish to amend the Agreement as set forth in this Amendment by changing company name from ENA Services, LLC, to Zayo Education, LLC.

NOW, THEREFORE, for and in consideration of the promises, term, covenants and conditions set forth herein the parties agree to revise the Agreement as follows:

Change company name from ENA Services, LLC, (“ENA”) to Zayo Education, LLC ("ZAYO EDUCATION") thus any documents referencing ENA shall now be known as ZAYO EDUCATION.

All other terms and conditions of the Agreement not revised herein shall remain unchanged and in full force and effect.
