Approval to Advertise: The School Board of Clay County, Florida ("the Board") approves the advertisement of revisions to School Board Bylaws 0122.1, 0124, 0147.1, 0149, 0149.3, and 0168, revisions to School Board Policies 1130, 1211, 2421, 2431, 2431.01, 3120, 3120.03, 3120.08, 3124, 3130, 3211, 3220, 4120, 4120.03, 4120.08, 4124, 4130, 4211, 5223, 5335, 5410.01, 5430, 5514, 5780, 5830, 6152, 6520, 6605, 6608, 6610, 7217, 8100, 8330, 8405, 8407, 8470, 8475, 8810, and 9215, the adoption of School Board Policy 9211, and the rescission of School Board Policy 9211.

Purpose & Effect: The proposed amendments are intended to simplify, update, and ensure alignment of School Board Policies with state law, federal law, State Board of Education Rules, and other applicable rules and regulations.

Rule-Making Authority: The Board is authorized to adopt and modify School Board Policies under sections 120.54, 120.81, 1001.32, 1001.41, and 1001.43 of the Florida Statutes.

Laws Implemented: As listed in each proposed rule. The laws implemented by the above-referenced policy revisions are noted under each section of the Policy.

No statement or estimated regulatory costs has been prepared. Any person who wishes to provide information regarding the statement of estimated regulatory costs, or to provide a proposal for a lower regulatory alternative, must do so in writing within 21 days of this notice.

Person(s) Originating Policy Changes: The proposed policy was originated by the Superintendent and School Board in collaboration with the School Board Attorney.

Public Hearing: The Board intends to formally adopt revisions to School Board Bylaws 0122.1, 0124, 0147.1, 0149, 0149.3, and 0168, revisions to School Board Policies 1130, 1211, 2421, 2431, 2431.01, 3120, 3120.03, 3120.08, 3124, 3130, 3211, 3220, 4120, 4120.03, 4120.08, 4124, 4130, 4211, 5223, 5335, 5410.01, 5430, 5514, 5780, 5830, 6152, 6520, 6605, 6608, 6610, 7217, 8100, 8330, 8405, 8407, 8470, 8475, 8810, and 9215, the adoption of School Board Policy 9211, and the rescission of School Board Policy 9211 following a public hearing. **The public hearing shall be held on Thursday, November 5, 2026**, during the course of a Regular Board meeting, which begins at **6:00 p.m.** and takes place in the Boardroom at the Teacher In-service Training Center at Fleming Island High School, 2233 Village Square Parkway, Orange Park, Florida.
