

**INTERLOCAL AGREEMENT BETWEEN
THE SCHOOL BOARD OF CLAY COUNTY, FLORIDA**

and

The Clay County Sheriff's Office, Florida

RE: TRANSFER OF SCHOOL DISTRICT PROPERTY TO CCSO

This Interlocal Agreement is made and entered into as of the 6th day of June, 2024, by and between The School Board of Clay County, Florida, a body corporate and political subdivision of the State of Florida ("School Board") and **The Clay County Sheriff's Office, Florida** ("CCSO") (collectively "The Parties").

RECITALS

WHEREAS, Chapter 163, *Florida Statutes*, permits local governmental units to make the most efficient use of their powers by enabling them to cooperate with other localities on a basis of mutual advantage; and

WHEREAS, Chapter 274, *Florida Statutes*, permits a governmental unit to classify as surplus any of its property, the continued use of which is uneconomical or inefficient, and to offer such surplus property to other governmental units in the county or district for donation; and

WHEREAS, in 2018, the Florida Legislature enacted the Marjory Stoneman Douglas High School Public Safety Act, Ch. 2018-3, Laws of Florida ("MSDHS Public Safety Act"), which made significant school safety reforms and imposed upon all Florida public school districts numerous additional requirements to achieve greater safety and security for all public school students and staff; and

WHEREAS, the School Board determined at that time to form the Clay County District Schools Police Department (CCDSPD) to comply with the requirements of the MSDHS Public Safety Act for School Resource Officers, such that the CCSO was no longer utilized for such services; and

WHEREAS, the School Board recently determined to transition back to utilizing the CCSO for the provision of School Resource Officers at the commencement of the 2024 – 2025 school year in order to meet the requirements of the MSDHS Public Safety Act; and

WHEREAS, with the transition back to utilizing CCSO for the provision of School Resource Officers, the School Board has determined that some of the equipment and other property used by the CCDSPD will become surplus property, as it will no longer serve a useful function and that the continued custody of the property would be uneconomical; and

WHEREAS, the aforementioned property is otherwise in good condition and the School Board having considered the best interests of the School District, the School Board has determined that it is appropriate to donate this surplus property to the CCSO to equip CCSO School Resource Officers; and

WHEREAS, the donation of this surplus property will reduce the initial startup costs of the agreement between the School Board and CCSO to provide School Resource Officers; and

WHEREAS, the donation of this surplus property should reasonably occur prior to the commencement of the 2024-2025 school year.

NOW THEREFORE in consideration of the premises and mutual covenants contained herein, and for other good and valuable consideration, the receipt and the adequacy of which are mutually acknowledged, with each party accordingly waiving any challenge to the sufficiency of such consideration, it is mutually covenanted, promised, and agreed by the parties hereto as follows:

1. This Agreement is entered into pursuant to the provisions of Section 1006.12(1), *Florida Statutes*.

2. The School Board has determined, within the reasonable exercise of its discretion, that a variety of equipment currently used by the CCDSPD will become obsolete once CCSO begins providing School Resource Officers, and consistent with Section 274.05, *Florida Statutes*, the continued custody of this property would be uneconomical and inefficient. Accordingly, the School Board has determined that it is in the best interests of the School District to donate this property, as-is, to CCSO for the purpose of equipping School Resource Officers that will serve in the public schools within Clay County.

3. The property to be donated consists of the following items:

- a. Fifty (50) police vehicles, currently in use by the CCDSPD, see attached Exhibit A.
- b. Fifty (50) police radios, see attached Exhibit B.
- c. Miscellaneous equipment consisting of Handcuff cases, Handcuffs, Tactical Flashlights and Flashlight Holsters, Speed Lidar devices, and such other miscellaneous equipment used by the CCDSPD, see attached Exhibit C.
- d. Firearms, see attached Exhibit D
 - i. Fifty (50) AR-15 rifles
 - ii. Twenty-five (25) Glock 17
 - iii. Sixteen (16) Glock 19
 - iv. Eight (8) Glock Trainers

4. The School Board shall transfer the property described above to CCSO prior to, or contemporaneously with, CCSO assuming responsibility for providing School Resource Officers for the School District.

5. CCSO agrees to take possession of the aforementioned property, and to use such property to equip School Resource Officers assigned to schools within the School District.

6. CCDSPD will provide the most recent system report with an effective date to include items listed in Exhibit A, B, C and D accompanied by supporting documentation on the items below.

- a. Invoices i.e., purchase details for all items listed in Exhibit A (vehicles).
- b. Provide the capital asset threshold criteria and the depreciation policy for vehicles in Exhibit A.
- c. Tag, title and registration details on the items listed in Exhibit A (vehicles)

7. Upon such transfer and acceptance, CCSO will assume sole responsibility for this property on the same basis as any other property owned by CCSO and the School Board is relieved of any and all responsibilities or obligations with regard to this property.

8. Under no circumstances will the School Board be liable to CCSO or any other person or entity, for any direct, indirect, incidental, special or consequential damages arising out of or related to this donation or the subsequent use of the property. This provision shall survive expiration of this Agreement.

9. CCSO agrees that it will only use the property as stated in this Agreement and that it will not further transfer this property to any other entity except in accordance with the law.

10. This Agreement, and the contemplated transfer of the property described above, shall begin upon execution by Parties on such date and time as is mutually agreed upon.

11. No provision of this Agreement is intended to, or shall be construed to, create any third party beneficiary or to provide any rights to any person or entity not a party to this Agreement, including but not limited to any citizen or employees of the School Board and/or CCSO.

12. If any term or provision of this Agreement or the application thereof to any person or circumstances shall, to any extent, be held invalid or unenforceable, the remainder of this Agreement or the application of such terms or provisions, to persons or circumstances other than those as to which it is held invalid or unenforceable, shall not be affected, and every other term and provision of this Agreement shall be deemed valid and enforceable to the extent permitted by law.

13. This Agreement shall be governed by the laws of the State of Florida. Any legal action necessary to enforce this Agreement shall be held in a court of competent jurisdiction located in Clay County, Florida. No remedy conferred upon any party is intended to be exclusive of any other remedy, and each and every such remedy shall be cumulative and shall be in addition to every other remedy given hereunder or now or hereafter existing at law

or in equity, by statute or otherwise. No single or partial exercise by any party of any right, power or remedy hereunder shall preclude any other or further exercise thereof.

14. Entire Agreement. It is mutually acknowledged and agreed by the parties hereto that this Agreement contains the entire agreement between the County and the School Board with respect to the subject matter of this Agreement, and that there are no verbal agreements, representations, warranties, or other understandings affecting the same.
