- A quantity of 355 Battery Backup Systems with the following minimum technical specifications.
  - o 1440VA / 1350 Watts or better power rating
  - o Input NEMA 5-15P plug
  - o Output 6 (or more) 5-15R receptacles
  - o All of the output receptacles must be able to provide battery backup power
  - o Flexible rack/tower configuration. Mounting hardware for 2-post rack must be included
  - o Must automatically restart and provide power to connected equipment once power is restored after extended power outage, regardless of battery condition
  - o 36-month or greater warranty on hardware and battery
  - o Topology type-line interactive
  - o Output waveform type-sine wave
- A quantity of 8 Battery Backup Systems with the following minimum technical specifications.
  - o 2880VA / 2700 Watts or better power rating
  - o Input NEMA L5-30P plug
  - o Output 3 (or more) 5-15R receptacles
  - o All of the output receptacles must be able to provide battery backup power
  - o Flexible rack/tower configuration. Mounting hardware for 2-post rack must be included
