## **Coming into Schools**







- Attending a school day function, such as awards or a performance
- Eating lunch with your child

- Completing tasks for teachers or staff, on or off campus
- Helping with picture day
- Monitoring the cafeteria
- Helping with a class party
- Attending a PFA/PTO/SAC meeting
- Chaperoning a whole group field trip
- Level 1 Volunteers are ALWAYS in the presence of a CCDS employee

- Chaperoning a field trip with small groups separate from CCDS employee
- Chaperoning an overnight field trip
- Driving students in a vehicle without a CCDS employee
- Serving as a volunteer coach

## **Visiting CCDS Schools**









### **During School Day**

- 1. Bring ID to event
- 2. Sign in at front desk
- 3. Wear printed temporary badge
- 4. Stay in designated areas
- 5. Check out as directed and return badge



## **Volunteering in CCDS**









- Register in Raptor
- 2. Sign in at front desk
- 3. Wear printed temporary badge
- 4. Stay in sight of a CCDS employee
- 5. Check out at front office and return printed badge



## **Volunteering in CCDS**







- Register in Raptor
- 2. Complete Level 2 Form
- 3. Get fingerprinted
- 4. Pick up permanent badge at school
- 5. Wear badge when volunteering
- 6. Check in and out at the front office or with designated employee

### Fingerprinting

- \$83.75
- Valid for 5 years
- Valid at ALL CCDS events and locations
- Employees, Kelly Subs, and Active Vendors have existing fingerprints on file, and do NOT need to refingerprint.

## **CCDS Volunteering Policy**

#### HR 2.02 B.2.e and f

e. Volunteers who may be in close, unsupervised contact with students must have a fingerprint/background check. The cost for such a check shall be borne by the individual or the agency with which the volunteer works.

f. Fingerprint/Background checks shall be secured from the Florida Department of Law Enforcement (FDLE) and/or other appropriate law enforcement agencies on any prospective volunteer. All prospective volunteers shall have their name checked against the FDLE internet sexual predator/sexual offender list.


