On the listed date and time, I was dispatched to 1500 Gano Av (Orange Park Junior High) in reference to a burglary.

Upon arrival, I met with RP1, Michael Defeo. Defeo is a maintenance employee at the school. Defeo advised when he arrived at the school at 0745hrs, he found three portable buildings to have been broken into. The buildings were last known to be secure around 1200hrs on 1/23/10. Building 503 and 504 had the front window panes broken out and lights left on inside. Building 515 had a rear window pane broken out. I was unable to determine what was used to break the windows. The suspect(s) cleaned up and removed all of the broken glass except for one piece I located inside building 504. However, the panes that were broken out only left an eight inch tall gap for someone to crawl through.

The front doors to all three of these buildings were found unlocked and likely the location in which the suspect(s) exited. Portable building 503, a computer lab, had a gray Dell D505 laptop computer stolen off a desk inside. Defeo advised on 1/26/10 an administrator would be able to contact OPPD to give police the serial number of the stolen computer. Nothing was stolen from any of the other buildings. The computer was worth approximately \$800. Defeo advised the broken windows will cost approximately \$75 to replace. I was unable to locate any latent fingerprints or any further evidence left at the scene.
