As a result, of the Individual Education Plan (IEP) held February 5, 2015, the district has agreed to provide 117.25 hours of tutoring for (hereinafter "the child") as compensatory education. Additional time for compensatory education of 33 hours was added as a result of the April 7, 2015 IEP team meeting. This totals 150.25 hours of compensatory instruction.

Accordingly please consider this a letter of commitment to the following terms:

- 1. The parent will select a teacher who has Florida certification in Exceptional Student Education (ESE) and is highly qualified with an appropriate level two background clearance as required by Florida Statutes.
- 2. The parent has selected a teacher, Mary K. Raiford (hereinafter "the teacher") as the child's tutor. The teacher is currently a Duval County teacher and is highly qualified.
- 3. The teacher will be paid her hourly rate, currently \$49.33.
- 4. The schedule will be determined by the teacher and the parent, initially four hours per week.
- 5. Tutoring will be provided by the teacher and an employee of the School Board of Clay County. The cumulative hours of tutoring between the two providers shall not exceed 150.25 hours.
- 6. Each session will be documented on a district created form (attached).
- 7. The teacher will submit an invoice to the ESE Director which includes a brief summary of the activities of each tutoring session.
