

**CONTRACT FOR SERVICES
THE SCHOOL BOARD OF CLAY COUNTY, FLORIDA AND
CLAY BEHAVIORAL HEALTH CENTER**

AGREEMENT made this 20th day of August 2009, by and between the School Board of Clay County (SBCC) and Clay Behavioral Health Center (CBHC).

WHEREAS CBHC can provide facilitation of guidelines of McKinney-Vento in conjunction with SBCC Project REACH program in the area of the Title X American Recovery and Reinvestment Act (ARRA) for Homeless Education and

WHEREAS the School Board of Clay County desires to enter into a contract with CBHC for the receipt of the following described services upon the following terms and conditions.

NOW THEREFORE, in consideration of the mentioned promises, covenants, and conditions hereafter set forth, it is understood and agreed as follows:

1. SBCC will pay CBHC the total sum of thirty-nine thousand dollars (\$39,000.00) through the continuation of the Title X American Recovery and Reinvestment Act (ARRA) Grant which provides facilitation of additional program outreach services. The total amount will be paid in thirteen (13) monthly payments, commencing on September 30, 2009, according to the attached schedule.
2. Funds of up to \$39,000.00 will be provided through the Title X American Recovery and Reinvestment Act (ARRA) Grant and will make it possible for CBHC to collaborate with SBCC Project REACH Kids on behalf of the school district's identified homeless students.
3. CBHC will provide direct and indirect assistance to school personnel, community agencies, and identified students/families in the planning and implementation of the Title X American Recovery and Reinvestment Act Grant to include:
 - a) coordination between district schools and the Project REACH Kids program;
 - b) participation in monthly Kids Council and Mercy Ministry Meetings;
 - c) identifying and developing resource packets for families;
 - d) coordination of services for pre-k families and unaccompanied youth through individual contact, case management and outreach activities;
 - e) provide McKinney-Vento mandated expedited services for identified youth through the completion of Social Histories, Vineland, and ABAS;
 - f) maintain accurate and updated records for student and community contacts;
 - g) coordination and implementation of program guidelines as needed and determined by Project REACH Coordinator.
4. CBHC retains administrative supervisory responsibilities for CBHC staff. The SBCC may, however, ensure that the delivery of services is coordinated with and supportive of the primary role of the school system - the provision of homeless education services. Both parties shall cooperate in the development and implementation of mutually acceptable

policies and schedules which will govern both the SBCC and CBHC personnel in the delivery of services needed for the Project REACH Kids and families.

5. CBHC and any of its subcontractors shall be required to indemnify and save harmless the School Board of Clay County from all suits, actions, liabilities, damages, costs and expenses of every name and description brought against the SBCC based on personal injury, bodily injury (including death) or property damages (including destruction), received or claimed to be received or sustained by any person or persons arising from or in connection with any negligent act or omission of the CONTRACTOR or its subcontractors, its officers, employees, agents or assigns.
6. State and Federal statutes prohibit discrimination on the basis of race, age, sex, national origin, marital status, religion, or handicaps and both parties to the AGREEMENT fully comply with the terms of these acts.
7. The AGREEMENT can be canceled by either party with 90 days notice.
8. CBHC agrees to comply with School Board Policy 4.51, Human Growth and Development.
9. CBHC personnel shall undergo and pass a Level II background screening as required By Fla. Stat. 1012.465, 1012.467 and 1012.468 prior to having any contact with students or entering upon school grounds when students are present. Proof of clearance shall be provided to the Director of ESE/Student Services of SBCC.
10. The Board shall pay CBHC in accordance with the Florida Prompt Payment Act all authorized charges for services performed and invoiced.
