On Thursday November 2nd, 2006 at 0909 hours, while assigned as the Youth Resource Officer at Lake Asbury Jr. High School I was contacted by the Vice Principal a Mr. Orzo May who stated that sometime during October 31st and November 1st that an unknown persons entered a portable 402 and removed one Dell table top computer. This includes the monitor, keyboard, tower and speakers.

I then spoke to the teacher a Mrs. Karen Faucett who stated that when she entered her classroom on Wednesday November 1st, she noticed that one of her tables had been moved, when she looked up she noticed that one of her classroom computes was missing. The items that was missing are a Dell table top computer, that includes monitor, tower and keyboard. The serial number CCSB 85945.

There are no signs of forced entry on either door. Mrs. Faucett did state that the back door does not always lock when closed. I asked her what does she mean? She replied, that the door will lock but a person can pull it open. I also contacted the schools maintenance personal in reference to the door and had them fix the problem. I contacted NCIC by phone and spoke to Operator Akins who entered the stolen item in to NCIC. all statements were sworn to wit they raised their right hand and swore the truth. Sergeant Lee 717 was informed of the incident.

This case is active pending further investigation.
