


# Proposed WES K-5







#### ATTENDANCE ZONE AS FOLLOWS:

Begin at a point of intersection between the center line of the North Fork of Black Creek and the south section line of Section 14, Township 5 South, Range 23 East, said point also lying on the north border of Camp Blanding for the point of beginning: thence east along the south section line, also being the northern border of Camp Blanding, to the northeast corner of Section 19, Township 5 South, Range 24 East; thence south along the section line to a point of intersection with the north section line of Section 30, Township 5 South, range 24 East and the center line of Alligator Boulevard; thence east along the centerline of Alligator Boulevard to a point of intersection with the center line of Masters Road; thence north along the center line of Masters Road to the center line of Peppergrass Street; thence east along the center line of Peppergrass Street to the center line of Dolphin Avenue; thence north along the center line of Dolphin Avenue to the center line of Johns Cemetery Road; thence in a northwesterly direction along the center line of Johns Cemetery Road to a diagonal line projected fromto the southwest corner of Section 4, Township 5 South, Range 24 East; thence northeast along a diagonal line to the northeast corner of Section 4, Township 5 South, Range 24 East; thence north along the west section line of Section 34, Township 4 South, Range 24 East to a point of intersection with the center line of the

Black Creek; thence in a general northerly direction along the center line of the North Fork of Black Creek to a point where Big Branch splits off from the North Fork of Black Creek; thence generally west and south along the center line of Big Branch to the center line of Duckwater Branch; thence west along the center line of Duckwater Branch to the center line of County Road 218; thence southeast along the center line of County Road 218 to a point of intersection with the south section line of Section 6, Township 5 South, range 24 East; thence west along the section line to a point of intersection with the center line of the North Fork of Black Creek; thence south along the center line of the North Fork of Black Creek to the point of beginning.
