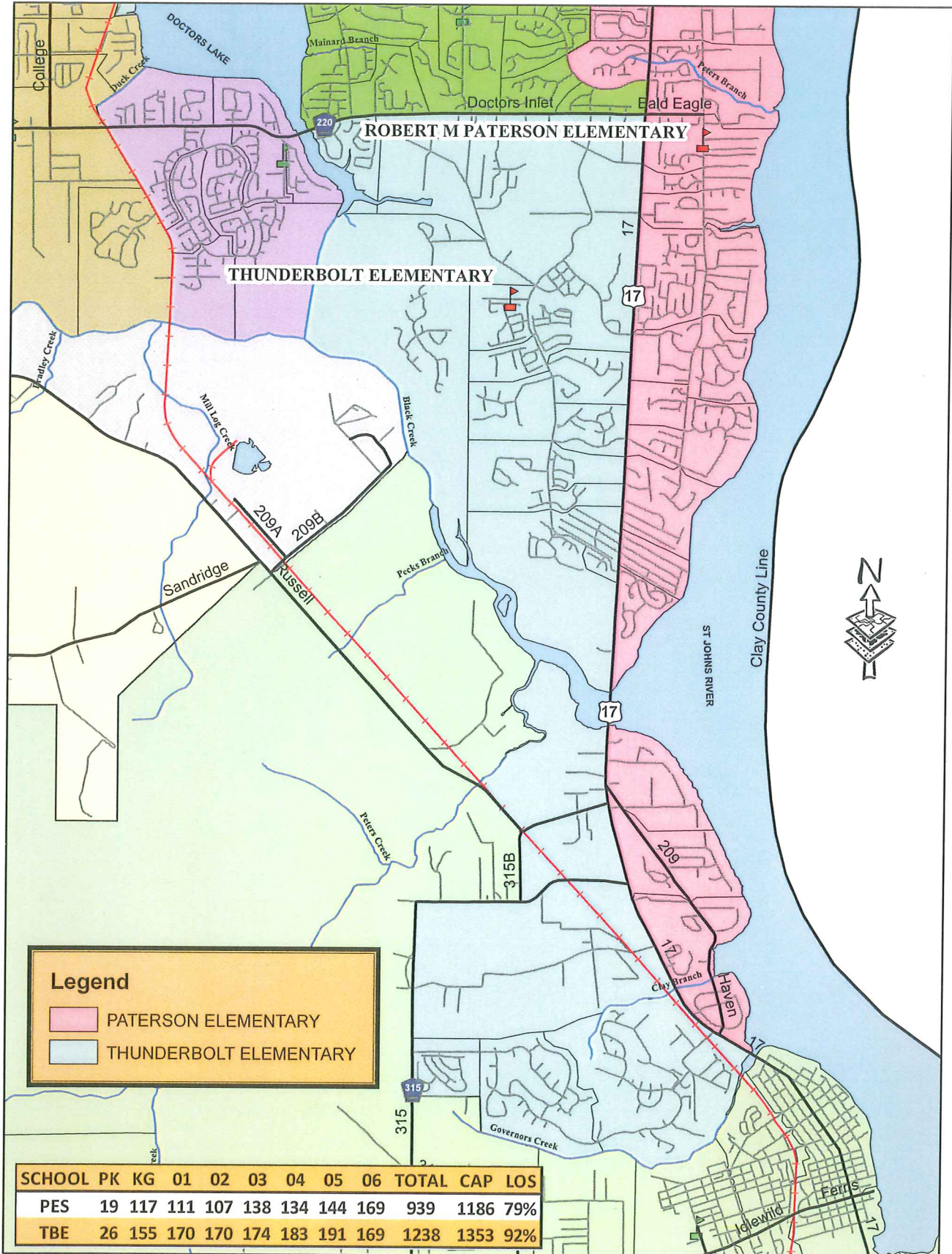


Current South of Black Creek & West of Highway 17 (From TBE to PES)

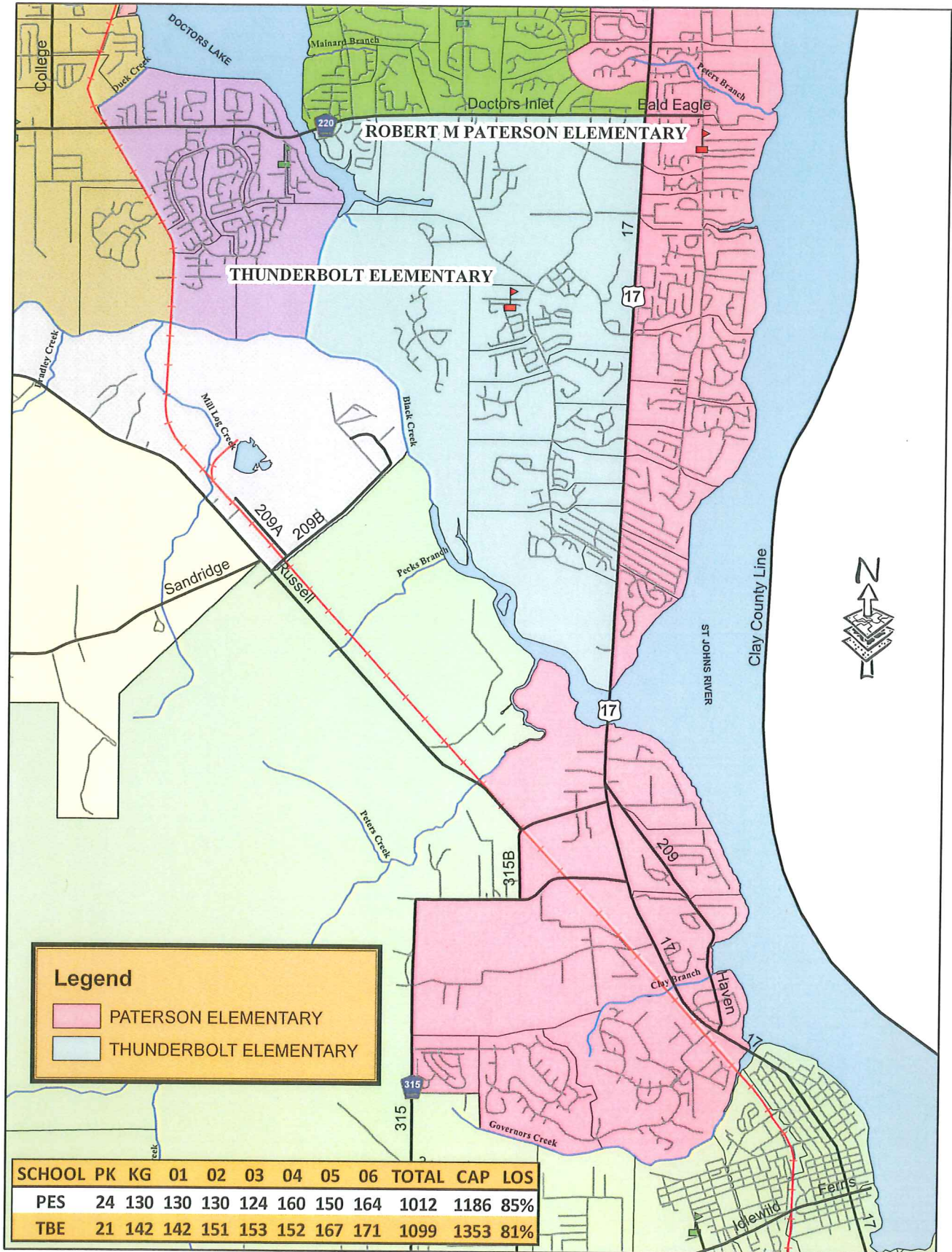

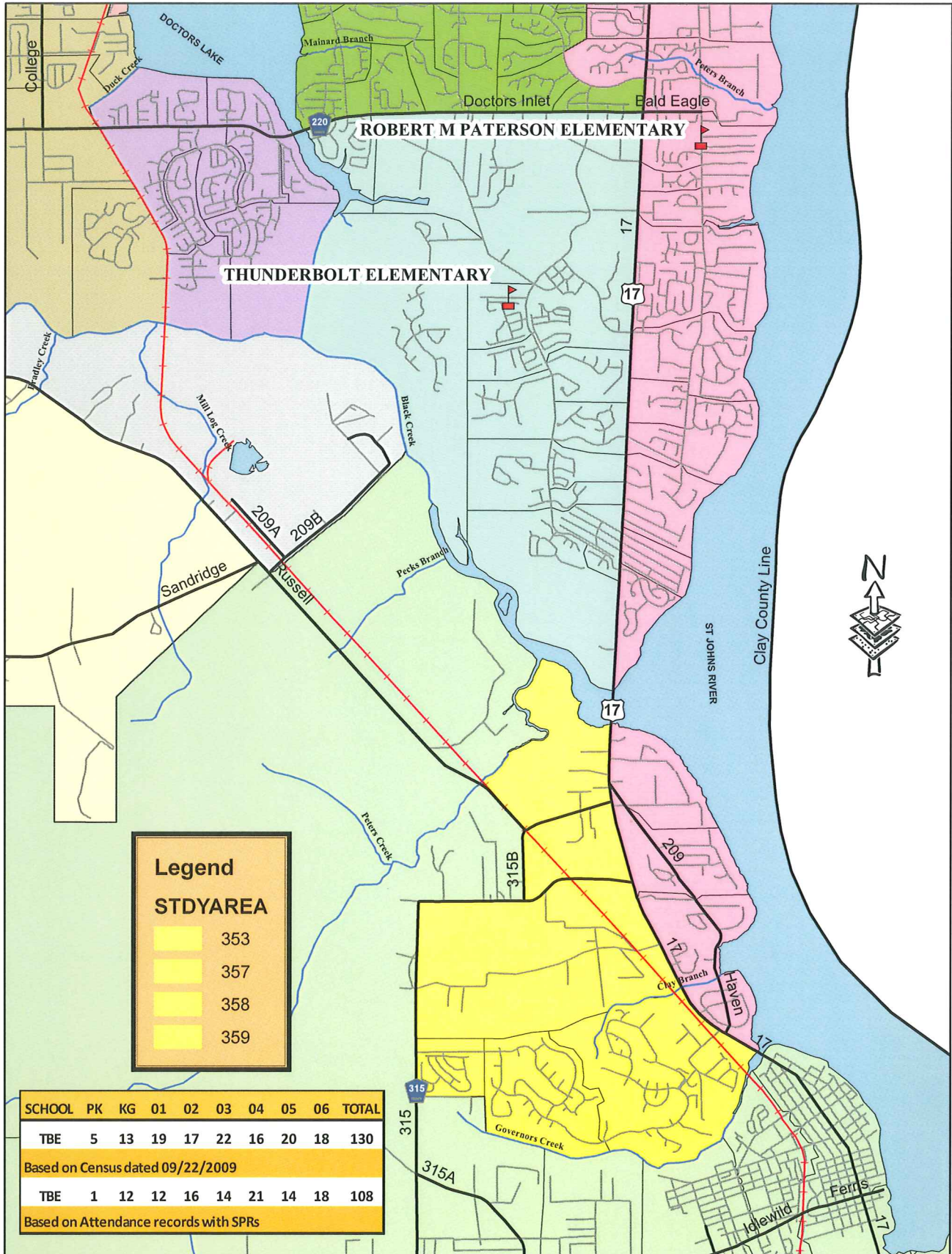
Proposed South of Black Creek & West of Highway 17 (From TBE to PES)

ATTENDANCE ZONE AS FOLLOWS:

A. Begin at the intersection of the center line of State Road 17 with the center line of Governor's Creek for a point of beginning, this point being in Township 6 South, Range 26 East; ~~thence from the point of beginning~~ in a northeastern direction from a point of intersection with the center line of State Road 17 and the center line of Governor's Creek to the eastern Clay County Boundary being in Township 6 South, Range 26 East; thence north along the eastern Clay County Boundary to a point directly east of a point of intersection with the southern shore of Doctors Inlet; thence west to ~~and~~ the center line of State Road 17 and the south shore of Doctors Inlet, being in Township 4 South, Range 26 East; ~~thence due west to the point of intersection between the southern shore of Doctors Inlet and the center line of State Road 17;~~ thence in a generally southwestern direction along the shore of Doctors Inlet and Doctors Lake to a point in Doctors Lake known as Mill Cove, this point also being the most eastern point of Mill Cove; thence from the most eastern point of Mill Cove in a straight line to the southeastern corner of Section 29 Township 4 South Range 26 East; thence south along the section line to a point north of Eagle Harbor BoulevardParkway, said point being 500 feet north of Eagle Harbor BoulevardParkway; thence in a eastern direction and parallel to Eagle Harbor BoulevardParkway to the center line of State Road 17; thence south along the center line of State Road 17 to a point of intersection with the center line of Governor'sBlack Creek; thence in a general westerly direction along the center line of Black Creek to a point of intersection with the center line of Peters Creek; thence southerly along the center line of

of the CSX Transportation Railroad tracks; thence southerly along the center line of the CSX Railroad tracks to a point of intersection with the center line of County Road 209 (Russell Road); thence in a general southeasterly direction along the center line of County Road 209 (Russell Road) to a point of intersection with the centerline of County Road 315B; thence south along the center line of County Road 315B to a point of intersection with County Road 315; thence west along the center line of County Road 315 to a 90 degree turn; thence south along County Road 315 to a point of intersection with the center line of Perry Road; thence east along the center line of Perry Road to the most eastern corner of Perry Road; thence southeast on a line projected from this corner 500 feet south and parallel to Colonial Drive to a point of intersection with the center line of Governors Creek; thence in an easterly direction along the center line of Governors Creek to a point of intersection with the center line of State Road 17, also being the point of beginning.

ATTENDANCE ZONE AS FOLLOWS:

Begin at the intersection of the center line of State Road 17 with the center line of Black Creek for a Point of Beginning, this point being in Township 5 South, Range 26 East: Thence from the Point of Beginning north along the center line of State Road 17 to the intersection of the center line of County Road 220 (Doctors Inlet Road); thence west along the center line of County Road 220 (Doctors Inlet Road) to a point of intersection with the center line of the Swimming Pen Creek; thence in a general southern direction along the center line of Swimming Pen Creek to the intersection of Black Creek; thence in a general southern direction along the center line of Black Creek to a point of intersection with the center line of Peters Creek; thence along the center line of Peters Creek to the center line of the CSX Transportation Railroad tracks; thence southerly along the center line of the CSX Transportation Railroad tracks to a point of intersection with the center line of County Road 209 (Russell Road), thence in a general southeastern direction along the center line of County Road 209 (Russell Road) to a point of intersection with the center line of County Road 315B, thence south along the center line of County Road 315B to a point of intersection with the center line of County Road 315, thence west along the center line of County Road 315 to a 90E turn, thence south along the center line of County Road 315 to a point of intersection with the center line of Perry Road, thence east along the center line of Perry Road to the most eastern corner of Perry Road, thence southeast on a line

~~projected from this corner, 500 feet south and parallel to Colonial Drive to a point of intersection with the center line of Governors Creek, thence in an eastern direction along the center line of Governors Creek to a point of intersection with the center line of State Road 17, thence north along the center line of State Road 17 to a point of intersection with the center line of Black Creek, the intersection of the center line of Black Creek and State Road 17, said point also being the point of beginning.~~
