Good morning,

Our annual State Officer Tallahassee Trip is scheduled for February 8-10. Thanks to our Board President, you are being afforded a marvelous opportunity, and I hope each officer truly appreciates all of Mr. Pierce's hard work on your behalf. You are strongly encouraged to live this opportunity to its fullest. Please remember that this is a MANDATORY event for all state officers.

I need each FBLA officer to email me back by 8 pm Thursday with your school/district approved chaperone. ***Please note that if someone other than your chapter adviser is your chaperone, they will be able to attend all meal functions, but none of the functions at the capital.***

Here are some important pieces of information regarding your trip:

1. We are staying at the Best Western Pride Inn and Suites, 2016 Apalachee Pkwy, Tallahassee, FL 32301. **(NOTE: This is a different hotel than the one we have used in the past.)** Please meet me in the lobby at 3 p.m. on Sunday and I will check you in. I will make officer and adviser/chaperone room reservations. If an adviser or chaperone prefers to have a single room, I need to know that by Thursday. The adviser/chaperone will then need to reimburse Florida FBLA-PBL for half of the room rate.
2. Officer teams will meet on Sunday afternoon and evening to plan their conferences.
2. Attire for dinner on Sunday night--khaki pants and officer polo. We will all go to dinner as a group around 6 p.m. Florida FBLA-PBL pays for the meal.
3. Attire for Monday--navy blue uniform. Don't forget your ties and scarves. (Advisers, FBLA-PBL business attire of your choice)
4. Dinner on Monday night will be as a group. Florida FBLA-PBL pays for the meal.
5. Attire for Tuesday--blue and khaki uniform. (Advisers, FBLA-PBL business attire of your choice)
6. Florida FBLA-PBL will reimburse for gas (with receipts). We have two FBLA officers in Miami. Florida FBLA-PBL will reimburse for a van rental if those advisers and students car pool. I am asking Ms. Alvarez to work with me on the travel arrangements. In addition, they may be able to pick up Alisa and her chaperone in Palm Beach County. I will be in touch with the three advisers who are affected.
