On 10-28-14 I responded to 3028 Golden Pond Blvd, in reference to a burglary to a residence. Upon my arrival, I met with the victim, Eugene Cordeau, who stated an unknown suspect or suspects entered into his unoccupied residence and stole a 36" flat screen LCD television and a Dell laptop computer.

- E. Cordeau stated on 10-26-14 at 0800 hours, he and his family left the residence to attend church service. They returned to the residence at approximately 1600 hours and watched television in the living room. His 9 year old daughter went into the master bedroom to retrieve her Dell laptop computer, but observed it was not on the dresser. She also noticed the Samsung flat screen television was gone from the top of the bedroom dresser.
- E. Cordeau entered into the bedroom and noticed the items had been removed from the bedroom and began searching the residence. He did not observe any other items missing throughout the residence. E. Cordeau then left town for business and returned on today's date and reported the burglary.
- E. Cordeau stated he believed the unknown suspect(s) entered into the residence through the rear sliding glass door, due to possibly being left unlocked. E. Cordeau stated he does not have any serial numbers for the stolen items and that the laptop computer, valued at approximately \$500.00, belonged to the Clay County School Board. The Dell Laptop computer was provided to his 9 year old daughter, due to her attending the Clay Virtual Academy. He also stated the Samsung television, valued at \$300.00, was a promotional item provided by AT&T for signing up for their service.
- E. Cordeau was questioned about possible suspect(s) or if any other individuals had access to their residence. He stated only he and his wife have keys and no one else has been inside the residence. E. Cordeau believes it was possibly juveniles in the area, due to them using his unfenced yard to enter into the rear of the residence to fish the pond. He said that the blinds were torn and they could see directly into the living room from the rear of the residence and notice no one was inside the residence.

I conducted a walkthrough of the residence with E. Cordeau and observed multiple items of value. If the suspect(s) entered through the rear sliding glass door, they would have walked by a video game console system, several video games and a flat screen television in the living room. Located next to the area where the items were stolen, a case containing a \$1000.00 camera was not disturbed. E. Cordeau stated he had fixed the rear sliding glass door so that the blinds would shut completely and also uses a bar locking system on the door.

Due to the victim cleaning the area of the burglary, the victim's kids coming in and out of the sliding glass door and the timeframe from the occurrence of the burglary the scene was not processed.

A neighborhood canvassed was conducted with the following results:
3024 Golden Pond Blvd- Louis Hughes (904-728-1486) Did not see or hear anything suspicious. She does observe juveniles using the victim's property as a cut through to the pond.

3027 Golden Pond Blvd. - No Answer

3031 Golden Pond Blvd- Diane Wenzel (904-778-0359) Was home all day and did not see or hear anything suspicious.
