Offense GRAND THEFT - VALUE 300 TO 4,999

On today's date while assigned to the Juvenile Crime Section (OPHS), I investigated a grand theft complaint. Upon meeting with Mr. Anthony Williams (assistant principal), he said that a Dell lap top computer was missing from the school. Mr. Williams discovered the computer missing as he was doing his inventory. Mr. Williams further said that the listed property was assigned to Mrs. Cassandra Osborne (teacher), and has been missing since this summer (2008).

Investigation revealed that the listed equipment was assigned to Mrs. Osborne. Upon interviewing Mrs. Osborne, she said the last time she saw the lap top was in December (2007). At this time the listed item was in the cabinet. Mrs. Osborne went on maternity leave in December (2007), and Mr. Burney Evans replaced Mrs. Osborne for the remaining of the year. Upon interviewing him (via phone), he said that he never saw a lap top in the classroom, nor did he sign for any property.

Mr. Williams said that the lap top computer was never assigned to anyone, but Mrs. Osborne. I also called Robin Haskins (CCSB), in regards to checking the CCSB# (attached to computer) county wide. Robin said that she would check the CCSB property system to see if the property was at another location.

At this time there are no known suspects regarding this case.


