

## **ESE CONSULTATIVE CONTRACT FOR SCHOOL YEAR 2009-2010**

### Services:

This is a contract to provide assistance to the ESE Department of The School District of Clay County. Services include writing, monitoring, and assisting in implementing activities responding to IDEA and ARRA Grant requirements. Expansion and budgeting of Medicaid, private contracts for services including Lighthouse Learning Center and Clarke Schools. Finally to assist with special cases, programs, policy review including assisting with audits, due process hearings, mediation meetings and resolution meetings. This contract would provide one and a half days per week of these services from the company: **Dan Becton Consulting, LLC**. This will assist the new .5 Director in dealing with ESE Implementation.

### Qualifications:

Dr. Becton has been the Director of ESE and Student Services for three years for Flagler District Schools. He has been the ESE Director for The School District of Clay County for 17 years. He has managed the IDEA grants, other federal grants, and wrote the ESE ARRA grant this year. The Curriculum Vitae for Dr. Becton is attached. ### Rate, Schedule, Payment:

Contract period is from July 2, 2009 to June 30, 2010. It will be funded from contracted services partially in the IDEA grant and partially in the ARRA grant. The contractor will be on site for Tuesday for a full day (7.50 hour) and Thursday for approximately a half day (4.00 hour). Other days can be substituted by mutual agreement of both parties. The contractor will not be available during the AMM week and FASP meeting week. The contractor will not be available for scheduling between July 10 and July 31, 2009 or between Dec. 16, 2009 and Jan.3, 2010. The contract shall be billed monthly to The School District of Clay County at the rate of \$65.00/hr based on the hours of service performed that month. Any hours scheduled in addition to those scheduled for Tuesdays and Thursdays as previously set forth herein shall be billed at a rate of \$75.00 per hour.

Conditions:

The contractor will maintain current certification and licensure. Either party may cancel the contract with a one month notice. The contractor will maintain a level II background clearance as required by Fla.Stat. 1012.465 and 1012.467.
