#### **REVISED 5/25/2006**

During our inventory process this year, our department has been unable to locate the items listed on the attached report. The majority of the items listed are battery backup devices (APC), and we expect them to be located in the near future.

The APC devices are co-located with network equipment and servers, so they should be easily identified. We have contacted key individuals at the schools in an attempt to locate these items and have met with limited success. We have also assigned our Technicians to visit each location where these items could be installed, and they will report any items they find.

Additionally, there are some older computers and printers on the list which may have been used for parts or transferred by District Office staff to other schools.

One of the items listed is a very old IBM Terminal that was used for access to the AS/400 system a very long time ago. This item was purchased in 1991, and was most likely discarded without following the proper procedure for assets with a book value over \$500.00. This IBM 4377 terminal is extremely old and has virtually no market value.
