I contacted Clay County Sheriff's Office pawn clerk Kathy Bowen who placed the projector on a pawn watch(#2001). See property sheet for description.


No evidence was obtained at the scene due to the fact the projector had been out in the open and just unplugged from wires which were attached at the time.
