The State Leadership Summit (SLS) is designed to be the beginning of the delegate process that will culminate at the 87th State FFA Convention & Expo in June/July. During this conference, officers will help decide the future direction of the Florida FFA Association by discussing ideas and issues that are important to FFA and Agricultural Education. Students in attendance will form issue committees that will evaluate feedback from FFA chapters across the state and make recommendations to the delegate body at the state convention in June/July.
