The Duties have been amended to include the District's Wellness Policy. Job Description:

The Network Services Coordinator is directly responsible to the Chief Information Officer and indirectly responsible to the Manager of Computer Operations and Supervisor of Information Services. He/she has primary responsibility for activities related to Data Networks, Software Support, Server planning, and Data Communications to support the District. Designs, develops, and implements software packages for web sites utilizing multiple programming packages. Facilitates Joint Application Design sessions with departmental representatives and documents the results of the effort by creating User Requirement Documents.

Responsibilities and duties of this position include:

- 1. Analyze computer hardware, software and networking requirements to prepare recommendations to meet district needs. Assists other staff members in developing Web based skills
- 2. Supervise work flow for maintaining and repairing district hardware and software. Analyzes, debugs and implements software code.
- 3. Review Technology changes and offer alternatives to more effectively and efficiently support hardware and software. Relies on experience and judgment to plan and accomplish goals.
- 4. Assist in the design and documentation of system requirements and system specifications throughout the district.

 Works directly with other departments to define requirements and propose solutions.
- 5. Assist school and district personnel in the selection, organization, and use of appropriate technological software, hardware, and related resources. Insures that all applications are developed with sound security to protect information in accordance with School Board Policy and State law.
- 6. Supervise and assist in the development and implementation of the district and school technology plans, comprehensive planning and budgeting, and the development of procedures for technology specialists and advisors. Prioritizes his own work with direction from others to achieve the most effective service to the District.
- 7. <u>Provide direct support for configuration of Cisco routers and switches.</u> A great degree of creativity and latitude are required.
- 8. Generate and maintain documentation necessary to the successful execution of the job; i.e. software inventory, hardware inventory, IS procedures, Project plans, Disaster plans. Perform other duties as requested by the Chief Information Officer.
- 9. <u>Coordinate the setup of computer and telecommunications networks district wide, including maintaining related records and information.</u> Develops and maintains Portals (website, online store, extranet, intranet)
- 10. Provide Professional Development for assigned staff as needed. Ensures User Accessibility to the site.
- 11. Perform such other tasks and assume such other responsibilities as the immediate supervisor may assign.

 Monitors Site traffic.
- 12. Analyzes web statistics.
- 13. Publishes all content to the website.
