BACKGROUND OF LOGISTICS CAREER PATHWAYS:

Currently the Northeast Florida Region have seven (7) International Trade and Logistics High School Career Academies

- Duval (3) First Coast, Lee and Forrest High Schools
- Clay Clay High School
- Baker Baker High School
- Columbia Columbia High School
- St. Johns Ponte Vedra High School (International Business and Marketing only)

Six (6) of these academies are utilizing the Global Logistics and Supply Chain Technology Frameworks in which 12 hours of their studies articulate into the FSCJ Supply Chain Management AS Degree program.

Most of these career academies started in the past 3-5 years and students have benefited as follows from two grant funding streams: a FDOT Garret Morgan Grant w/UNF – funding expired in 2011 and a Community Based Jobs Training Grant (CBJT) w/FSCJ – funding expires in late 2013.

- Scholarships
- Student Internships
- Logistics Summer Camps
- Teacher Externships

NEED / OPPORTUNITIES:

- FSCJ has a strong business partner Advisory Council that has assisted with all high school and post-secondary programs. Most of the support has been in-kind. There is a strong need to sustain the programs and student funding for educational growth beyond the current DOL CBJT grant which expires late 2013.
- The Port of Jacksonville is slated to grow tremendously over the next 5-10 years. Port and logistics companies
 are needing "qualified" candidates for the jobs of tomorrow. Many today tell us that they don't have the local
 qualified workforce. Engaged business partners and education make for a great mix for continued prosperous
 growth in our region.
- Business partners can fund and support various educational programs after grant monies expire. Businesses can also assist with in-kind or monetary support on future grant applications

PURPOSE and EXPECTED OUTCOMES OF THE PORT OF LA VISIT:

The intent of this trip is for JAXPORT and FSCJ to visit the Port of LA and it's business partners to observe ways that they raise monies to sustain programs. Currently the Port of LA works closely with business partners and a non-profit organization called International Trade Education Programs (ITEP) http://itepinc.org/. ITEP sponsors and hosts an annual fundraising dinner by inviting hundreds of Port and Logistics professionals to an Annual Scholarship Dinner. Each Career Academy is represented, the "best-of-the-best" students/scholarship recipients present their experiences at the dinner and usually a predominant figure in the port and logistics arena is recognized. Students from the participating school culinary programs make and host the dinner. All funds raised are spent on educational scholarships, internship and programs for the Career Academy Students.

It is our hope that the group of JAXPORT, FSCJ, educational and business partners who attend this trip can learn from the ITEP program and implement one similar in Northeast Florida.

WHY FSCJ?

- Students in the Logistics Career Academies will earn 12 Credit Hours that Articulate into FSCI's AS Degree as stated above. These students become the "feeder-pattern" for the college....creating sustainability.
- FSCJ has a Foundation that can collect and properly distribute the funds to the High Schools.
- FSCJ owns the Certification rights to the American Society of Transportation and Logistics (ASTL) Professional Designation in Logistics and Supply Chain Management (PLS) Certification. Even if other local colleges (ie: Florida Gateway College and St. Johns River State College) offer the AS pathway....FSCJ can still own the rights to administer the PLS Certification, a funding stream in itself.
- FSCJ is already known in our community to be a logistics leader in education.
- Staffing capability to administer a logistics program.

PORT OF LA ITINERARY – May 13-16, 2012:

- Tour of the Port of LA Harbor Learn about the Port and it's differences/similarities to Jacksonville
- Meet with the Executive Director of the International Trade Education Programs (ITEP) organization to learn how they raise and disperse their funds

- Learn from ITEP how they coordinate/organize their Scholarship Dinner. Determine Opportunities and Challenges.
- Visit to Banning High School one of the local High School Career Academies Discussion on articulation agreements
- Meet and Greet lunch/dinner with Port of LA and other Key Business Partners
- Meet with the Port of LA Student Internship Program Coordinator to see their model on how they run their programs
