

## CLARKE SCHOOL CONTRACT AMENDMENT

**THIS AMENDMENT** entered into this 17th day of May, 2012, by and between THE SCHOOL BOARD OF CLAY COUNTY, FLORIDA, hereinafter referred to as “Board,” and CLARKE JACKSONVILLE AUDITORY/ORAL CENTER, hereinafter referred to as the “Contracted School.”

**WHEREAS**, on July 1, 2011, the parties entered into a contract for education and related services for deaf and hard of hearing students; and

**WHEREAS**, it has been determined that extended school year (ESY) services for Clay County students have been recommended, which services were not contemplated by the original contract; and

**WHEREAS**, the parties agree as follows:

1. Eleven (11) students are in need of ESY services.
2. ESY shall take place five (5) days per week and shall run from July 2, 2012, through July 27, 2012, for a total of nineteen (19) days at Clarke School.
3. The cost per student for ESY services is ONE THOUSAND SIX HUNDRED FIFTY AND NO/100 DOLLARS (\$1,650.00) for a total of EIGHTEEN THOUSAND ONE HUNDRED FIFTY AND NO/100 DOLLARS (\$18,150.00).

**NOW, THEREFORE**, the parties agree to amend the above-referenced Contract as follows:

1. Extended school year (ESY) shall be provided to eleven (11) Clay County students by the Contracted School.

2. ESY shall be provided five (5) days per week beginning July 2, 2012, and ending on July 27, 2012, for a total of nineteen (19) days.
3. The payment per student to the Contracted School for ESY shall be ONE THOUSAND SIX HUNDRED FIFTY AND NO/100 DOLLARS (\$1,650.00) per student for a total of EIGHTEEN THOUSAND ONE HUNDRED FIFTY AND NO/100 DOLLARS (\$18,150.00).
4. The Contract is amended to reflect the increase in the Board's payment obligation as set forth in the paragraph immediately preceding this paragraph.
5. All other terms and conditions of the Contract entered into by the parties on July 1, 2011, shall remain unchanged and shall remain in full force and effect.
