- 1. An easement five (5) feet in width adjacent to and abutting the right-of-way of County Road 209 Extension running the entire distance where the GRANTOR's property fronts County Road 209 Extension.
- 2. An easement thirty (30) feet wide extending into GRANTOR's property along either side of the entrance driveway to GRANTOR's property for a distance of fifty (50) feet from the point at which said entrance driveway intersects County Road 209 Extension.
- 3. Said temporary construction easement is to be used during the time of construction of County Road 209 Extension for the purpose of tie-in of elevation from the back of the sidewalk running parallel to County Road 209 Extension to the GRANTOR's property.

- 4. GRANTOR hereby allows GRANTEE's contractor to cut or fill within this easement to make the slope maintainable for the future use of the GRANTOR. Any shrubbery, grass, or plants lying within the five (5) feet which are damaged by GRANTEE's activities in the easement will be replaced by GRANTEE with items of like, kind and size.
- 5. This temporary construction easement shall expire on the date that the GRANTEE releases final payment for the completed construction of the County Road 209 Extension.
