This course merge proposal is an addendum to the existing Master Terms between Global Synergies LLC and the School Board of Clay County, executed on July 19, 2007. All terms and conditions apply to this addendum.

### 1. PROJECT OBJECTIVE

The School Board of Clay County (“Clay”) is looking to integrate its LDAP identity management system into its Blackboard. This solution is will combine teachers’ Blackboard and network logins into one, stored and managed by LDAP.

### 2. SCOPE OF SERVICES

Global plans to coordinate personnel within Clay County to organize user accounts and integrate its LDAP service with Blackboard. More specifically, teacher usernames in Blackboard [that originate in TERMS] must match usernames in LDAP and Blackboard’s authentication schema is still required for students. The following is the list of services included in this proposal:

- Map out the solution, educating Clay personnel on the details of the LDAP integration behavior
- Review state of data, ensuring an agreement of usernames between Blackboard and LDAP
- Configure a “fallback” to Blackboard for student logins
- Configure the connection to LDAP for teacher logins
- Test the solution
- Deploy the new schema on Clay’s production system

### 3. PROJECT DELIVERY

The project’s delivery will follow standard development practices. First, Global will define the plan with the Clay team and ensure all stakeholders understand the new solution. Next, Global will configure and test the solution within Clay’s test environment. Once it passes Clay’s testing, the solution will be put into production.

This will be delivered remotely.

### 4. TERMS AND CONDITIONS

- Clay will provide a project manager to serve as Global’s primary point of contact throughout the project
- Global’s consultants require access to Clay’s Blackboard servers. Additionally, Global will require a system administrator account on its Blackboard system.
- This is a standard Blackboard solution. Global will follow Blackboard’s documented configuration process when implementing the LDAP solution
- Global is not responsible for the Blackboard Academic Suite installation
- Global will ensure the strictest security and confidentiality of all provided data/records and will discard any such materials upon project completion
- Clay will be invoiced at the conclusion of the project. All invoices will be in US dollars and include all applicable taxes. Clay agrees to pay invoices in accordance with the Florida Prompt Payment Act.

### 5. COSTS AND PROFESSIONAL FEES

Software costs are summarized in the below schedule.
