

SCHOOL BOARD MEMBER: DISTRICT BOUNDARY DESCRIPTIONS

District 1

All of the County lying within the area bounded by the following line: Point of Beginning being the centerline of the confluence of Doctors Lake and the St. Johns River; thence south along the centerline of the St. Johns River until it intersects with the centerline of the confluence of Black Creek and the St. Johns River; thence in a westerly direction along the centerline of Black Creek until it intersects with the centerline of Little Black Creek; thence in a northerly direction along the centerline of Little Black Creek to a point of intersection with the centerline of County Road 220; thence east along the centerline of County Road 220 to a point of intersection with the centerline of Knight Boxx Road (SR 220B); thence north along the centerline of Knight Boxx Road (SR 220B) to a point of intersection with the centerline of Old Jennings Road; thence east along the centerline of Old Jennings Road to a point of intersection with the centerline of College Drive; thence south along the centerline of College Drive to a point of intersection with the centerline of Brickyard Road; thence in an easterly direction along the centerline of Brickyard Road until it intersects with the centerline of the CSX Railroad tracks; thence in a northerly direction along the centerline of the CSX Railroad tracks until it intersects with the centerline of an unnamed waterway; thence east along the centerline of the unnamed waterway until it intersects with the centerline of Doctors Lake; thence east along the centerline of Doctors Lake until it intersects with the centerline of the confluence of Doctors Lake and the St. Johns River to the Point of Beginning.

District 2

All of the County lying within the area bounded by the following line: Point of Beginning being the centerline of the confluence of Doctors Lake and the St. Johns River; thence north along the centerline of the St. Johns River to a point of intersection with the northeastern corner of the Clay County boundary line; thence west along the northern boundary line of Clay County to a point of intersection with the eastern plat boundary line of the Country Club of Orange Park, Unit 8, thence east and south and thence west and south along the plat boundary lines of the Country Club of Orange Park Units 10, 8, and 1 where the boundary line adjoins to the north plat boundary lines of Loch Rane Estates; thence east along the north plat boundary line of Loch Rane Estates and continue along the northern boundary line of Loch Rane Re-Plat Unit One to its eastern boundary; thence south along the eastern Boundary of Loch Rane Re-Plat Unit One, then continue along the same bearings to the centerline of Loch Rane Boulevard; thence east along the centerline of Loch Rane Boulevard to a point of intersection with the centerline of Blanding Boulevard (SR 21); thence in a southwesterly direction along the centerline of Blanding Boulevard (SR21) to a point of intersection with the centerline of Little Black Creek; thence south along the centerline of Little Black Creek to a point of intersection with the centerline of County Road 220; thence east along the centerline of County Road 220 to a point of intersection with the centerline of Knight Boxx Road (SR 220B); thence north along the centerline of Knight Boxx Road (SR 220B) to a point of intersection with the centerline of Old Jennings Road; thence east along the centerline of Old Jennings Road to a point of intersection with the centerline of College Drive; thence south along the centerline of College Drive to a point of intersection with the centerline of Brickyard Road; thence in an easterly direction along the centerline of

Brickyard Road to a point of intersection with the centerline of the CSX Railroad tracks; thence north along the centerline of the CSX Railroad tracks to a point of intersection with the centerline of an unnamed waterway; thence east along the centerline of the unnamed waterway to a point of intersection with the centerline of Doctors Lake; thence east along the centerline of Doctors Lake to a point being the centerline of the confluence of Doctors Lake and the St. Johns River to the Point of Beginning.

District 3

All of the County lying within the area bounded by the following line: Begin at the southwestern most point of Clay County for a Point of Beginning; thence in an easterly direction along the southern boundary line of Clay County to a point of intersection with the centerline of Hogarth Road; thence north along the centerline of Hogarth Road to a point of intersection with the centerline of Greens Creek; thence north along the centerline of Greens Creek to a point of intersection with the centerline of South Fork Black Creek; thence north along the centerline of South Fork Black Creek to a point of intersection with the centerline of State Road 16; thence east along the centerline of State Road 16 to a point of intersection with the centerline of Thunder Road; thence north along the centerline of Thunder Road to a point of intersection with the centerline of County Road 218; thence west along the centerline of County Road 218 to a point of intersection with the centerline of Blanding Boulevard (SR 21); thence north along the centerline of Blanding Boulevard (SR 21) to a point of intersection with the centerline of the North Fork Black Creek; thence north along the centerline of the North Fork Black Creek to a point of intersection with the northern boundary line of Census Block number 2011; thence in an easterly direction along the northern boundary of Census Block number 2011 to a point of intersection with the centerline of Junction Drive; thence east

along the centerline of Junction Drive to a point of intersection with the centerline of Old Jennings Road; thence east along the centerline of Old Jennings Road to a point of intersection with the centerline of Live Oak Lane; thence north along the centerline of Live Oak Lane to its intersection with the eastern boundary of Census Block number 1131, thence in a northerly direction along the eastern boundaries of the following Census Block numbers 1131, 1132, 1133, 1080 and 1071 to a point of intersection with the northern boundary line of Clay County; thence west along the northern boundary line of Clay County to a point of intersection with the western boundary of Clay County; thence south along the western boundary line of Clay County to the Point of Beginning.

District 4

All of the County lying within the area bounded by the following line: Begin at the northern boundary of Clay County and the point of intersection with the eastern boundary of the Platt of Country Club of Orange Park, Unit 8, thence east and south and thence west and south along the plat boundary lines of the Country Club of Orange Park Units 10, 8, and 1 where the boundary line adjoins the north plat boundary line of Loch Rane Estates; thence east along the north plat line of Loch Rane Estates and continue east along the north boundary line of Loch Rane Re-Plat Unit One to its eastern boundary; thence south along the eastern Boundary of Loch Rane Re-Plat Unit One then continue on along the same bearings to the centerline of Loch Rane Boulevard; thence east along the centerline of Loch Rane Boulevard to a point of intersection with the centerline of Blanding Boulevard (SR 21); thence south along the centerline of Blanding Boulevard (SR 21) to a point of intersection with the centerline of Old Jennings Road; thence west along Old Jennings Road to a point of intersection with the centerline of Live Oak Lane; thence north along the centerline of Live Oak

Lane to its point of intersection with the eastern boundary of Census Block number 1131; then in a northerly direction along the eastern boundaries of the following Census Block numbers 1131, 1132, 1133, 1080 and 1071 to a point of intersection with the northern boundary line of Clay County; thence east along the northern boundary line of Clay County to the Point of Beginning.

District 5

All of the County lying within the area bounded by the following line: Begin at the southeastern most corner of Clay County for a Point of Beginning; thence west along the southern boundary line of Clay County until a point of intersection with the centerline of Hogarth Road; thence north along the centerline of Hogarth Road to a point of intersection with the centerline of Greens Creek; thence north along the centerline of Greens Creek to a point of intersection with the centerline of the South Fork Black Creek; thence north along the centerline of the South Fork Black Creek to a point of intersection with the centerline of State Road 16; thence east along the centerline of State Road 16 to a point of intersection with the centerline of Thunder Road; thence north along the centerline of Thunder Road to a point of intersection with the centerline of County Road 218; thence west along the centerline of County Road 218 to a point of intersection with the centerline of Blanding Boulevard (SR21); thence north along the centerline of Blanding Boulevard (SR 21) to a point of intersection with the centerline of North Fork Black Creek; thence north along the centerline of North Fork Black Creek to a point of intersection with the northern boundary of Census Block number 2011; thence in an easterly direction along the northern boundary of Census Block number 2011 to a point of intersection with the centerline of Junction Drive; thence east along the centerline of Junction Drive to a point of intersection with the centerline of Old Jennings

Road; thence east along the centerline of Old Jennings Road to a point of intersection with the centerline of Blanding Boulevard (SR21); thence north along the centerline of Blanding Boulevard (SR 21) to a point of intersection with the centerline of Little Black Creek; thence south along the centerline of Little Black Creek to a point of intersection with the centerline of Black Creek; thence east along the centerline of Black Creek to the centerline of the confluence of Black Creek and the St. Johns River; thence south along the St, Johns River to the Point of Beginning.
