

Changes to Student Progression Plan (2013-14)

Entire "Progression Plan" – add "2.0" to all references to FCAT;

P. 3 – Inserted "RtI" in place of Progress Monitoring Plan (2nd paragraph);

P. 17 – Changed section from Progress Monitoring Plan to Response to Intervention Plan/Progress Monitoring" - informing parents that schools no longer are required to create Progress Monitoring Plans. Frequent progress monitoring data will be collected for this purpose Interventions within the "Response to Intervention" process will become accepted practice; deleted outdated information

P. 18 – New "RTI Academic Plan" added to section; deleted "Progress Monitoring Plan/Remediation" chart from 2012-13 plan;

P. 22 – Changed FAIR administration to K-2 instead of K-6; added information about "Performance Matters;"

P. 25 – added information dealing with "Report Cards K-2";

P. 29 – (c)(4) – changed from "two" to "three" the number of required examples of mastery; (d) changed "Progress Monitoring Plan" to "RtI"; (D) deleted "Next Generation and/or";

P. 30 – Changed language to refer to a "120 minute literacy block" (A)(1);

P. 31 – deleted information on "Progress Monitoring Plan." Change to "individual intervention plan";

P. 34 – changed language to refer to a "120 minute literacy block (j);

P. 35 – deleted sentence in (A)(3) about parent request to have child retake a different version of the SAT-10;

P. 37(B)(2) – Principal's Responsibility – Good Cause (F.S. 1008.25) – new procedures for promotion of a student for "Good Cause";

P. 39 – Added "Reading Camp" to section heading;

P. 41 – deleted "K12" reference; added information about students outside the District being able to participate in CVA (also referenced on p. 78);

P. 48 - "**Bright Futures Scholarship**" Program - Added additional information concerning criteria and source of information pertaining to "Bright Futures Scholarship" program;

P. 50 - added the following: "Students must be enrolled at the school hosting the NJROTC unit." **Course Sequencing/Junior High School** – added information on 7th grade Civics course having an EOC and 30% of final grade;

P. 52 – **Credit Acceleration Program (CAP)** – Added information about the criteria to participate in CAP;

P. 53 – **End-of-Course (EOC) Exams** – Added information to this section concerning recent legislation in EOC’s and new diploma requirements;

P. 57 – **Graduation Exercises/Diplomas** – updated information on types of diplomas offered by the State of Florida;

P. 58-61 – **Graduation Options** – Deleted information about 18-credit options and added new diploma types and their requirements;

P. 67 – Added 2013-14 “**Students Entering Grade Nine in 2013-14 Graduation Chart**”;

P. 71 – **Online Graduation Requirement** – Updated information pertaining to the online course requirement;

P. 77 – “**Reading and Math Remediation**” – Changed exemption status to students in grades 7th-10th; new information on exemption status

P. 81 – “**Termination of School Placement at Age 16**” – Added this section to Student Progression Plan;

P. 86 – changes age limit of a student selecting a diploma option from 16 to 14;

P. 87 – added language in reference to the accommodations of students seeking a standard diploma;

P. 89 – deletes “Life Management or Life Skills” and “Vocational” (inserts “CTE”) categories;

P. 94 – deletes reference to “Next Generation Sunshine State Standards” and inserts “CCSS and Supplemental NGSSS Aligned to FCAT 2.0 and EOC’s; deleted final paragraph of ESE section;

P. 97 – added language that refers to maximum age limit for participation for the “Adult High School Credit Program”; Changed fees for Adult Education courses and references a “re-entry” fee of \$10.00;
